#### Approval of February 18 minutes: Vicki - unanimously approved

### **Treasurer's Report: Terry**

- For May we were \$22,596 in the red which is for new cages and expenses for the new shelter
- Shelter expenses were \$48,186
- We bought new cages for \$10,000 that were not part of the plan; 2 needed to be upgraded, buying an additional spare one.
- We had an \$8000 expense for meds and vaccines which should last a long time
- We have 150 cats so costs are going to go up
- We now have a \$200,000 asset of the new shelter building
- Even though costs are running high, there is no panic yet
- We have \$6,314 in the shelter operating fund and \$57,435 in our short term investments
- Our capital campaign has raised \$72,435. We still need to raise \$127,127 to pay off our mortgage and renovation expenses
- Our regular donations are down
- There were no fundraisers for May. Looking ahead to June, the kitten shower raised \$1700 plus donated goods
- We raised \$1000 for capital campaign from the shower
- Bowling was a good event more than \$7,000
- We have received \$2,000 from PetSmart this year; July 18-21 is next adoption weekend at PetSmart

We will need to dismantle the cages and reassemble in the new shelter Teresa, Shelly, Erin and Denise will revisit the once-used cleaning schedule and update it for new shelter
