

To understand this post you must be aware that there are different jurisdictions of law.

Identical words can mean different things in different jurisdictions.

An analogy would be to think of the use of English and American words, which sound the same and are spelt the same, but mean quite different things depending on which side of the Atlantic the speaker comes from. 'Fanny' is a splendidly graphic example.

Physical objects exist in the **lawful** jurisdictions of the Land and Soil.

Intangible concepts such as companies only exist in the **legal** jurisdictions of the Sea or Air is always.

So you, as one of the people, might have a car, van or motorcycle which under the language of the jurisdiction of the Land or Soil you refer to as a vehicle.

However, when the judiciary refers to a vehicle they can only refer to something in their own jurisdiction. Their statutes, regulations and other instruments cannot refer to objects in the physical world.

So when the judiciary or government refers to a vehicle, it is referring to a financial instrument such as a trust with similar identification details as a car or whatever.

A legal financial vehicle is a certificate of deposit. That is exactly what the V5 vehicle registration document is.

Registering something means giving it to the Crown. Once something is freely given, it cannot be claimed back, so don't bother. But all you have done is donated the trust to their care.

The vehicle identification number will be part of the identifying code for the trust.

The vehicle trust, which exists in the non physical jurisdiction, doesn't just happen to have similar words describing it as your physical vehicle does by accident, the similar description is deliberately designed to fool people.

Not only can it fool the owner of a car, van, motorcycle or other physical vehicle, this use of seemingly identical words is designed to fool the front line, people facing servants of the government, the police and DVLA.

The police, DVLA and other government agents are deliberately kept in the dark about the different jurisdictions and meanings of words by their paymasters. If they weren't, the majority would probably do the right thing and let people go about their private business in their own unregistered, untaxed, non MOT'd cars without so much glance, as it is perfectly lawful to do so.

All the car tax you pay is voluntary. It has to be, the jurisdiction of the sea has no authority over living people.

These jurisdictions also explain why the police and armed services swear an oath to the Crown (an incorporated concept in the jurisdiction of the Air). The police can't swear an oath to the people as they operate in a different jurisdiction.

Furthermore when a statute refers to a person, it can't mean a living man or woman, because these physical objects do not inhabit the world of legal fictions. Correctly speaking they populate planet Earth.

The word 'person' in the jurisdictions of the sea and air once again refers to a financial instrument. Legally speaking a 'Person' is found in the jurisdiction of the sea and a 'PERSON' is found in the jurisdiction of the air. These are proper nouns which is why they are capitalised, but they can be referred to by the judicial descriptive noun 'person'.

The word 'person' is also used as a descriptive term in the jurisdictions of the Land and Soil. Once again the powers that be are quite happy for their living employees and everyone else that doesn't benefit from the deceit to get things mixed up.

The danger to living men and women is that all these financial instruments are unable to represent themselves in the legal world as, because they are intellectual concepts rather than living beings, they are unable to speak for themselves.

So the government/judiciary/financial institutions send invitations (bills or more often billing statements) to living people at their home addresses, essentially inviting the living man or woman to represent the totally unconnected, but similarly named financial instrument.

Should they agree to speak for the legal construct, they are then assumed to have voluntarily given themselves up to the consequences of accepting responsibility, which means they can then be fined or imprisoned.

It's the opposite of the vampire myth. A vampire can only enter the house of the living if invited. With the judiciary, the living can only be preyed upon if we volunteer to enter their world by accepting a contract or crossing the bar in a courtroom.

The answer is of course to not engage and educate the police and armed services about how they have been deliberately duped by their paymasters into doing work that they really shouldn't be doing.

Hence they have no authority to force a living person to go to school, pay any tax, wear a mask, be tested or vaccinated, or even require a driver's licence or passport, because they have no authority in our jurisdiction of the Land and Soil.
