Plan: Primarily Neighborhood sales, some booths

- 2 cases Thin Mints
- 2 case Caramel Delites
- 1 case Peanut Butter Patties
- 1 case Trefoils
- 1 case Lemonades
- 1 case Adventurefuls

Plan: Booth sales and neighborhood sales

- 5 cases Thin Mints
- 4 case Caramel Delites
- 3 case Peanut Butter Patties
- 2 case Trefoils
- 2 case Lemonades
- 1 case Adventurefuls
- 1 case Peanut Butter Sandwiches

Cookies are **\$5 a box**, each case has 12 cookies, so every case is a **\$60 commitment**. The cookies will sell faster than you think, especially Thin Mints!

Smart Cookies Website and App

- Create an account if you do not already have one
- Tracks inventory
- Direct ship online sales
- Scanning capabilities for iPhone users
- No additional card reader needed
- Girls and troops will be able to continue to utilize ABC Credit Card program in Smart Cookies.
- GSCTX will cover all fees associated with this program.

Square

- Sign up online
- Troop pays fees upfront
- GSCTX will reimburse fees of \$10-\$200 max

Stephanie Diden manages all cookie money.

She will inform you of the dates payments are due for transfer to the bank. These are also included in the key dates.

Social Media Rules

New rules focus only on things the caregiver can control on social media (e.g., not responsible for tags/comments from other people).

Caregiver may comment on any public post asking for Girl Scout cookies to let the poster know to send a direct message for more information.

Girls may use their parent's social media to advertise cookies with parent supervision.

Use only first name and troop number when advertising on social media. No phone numbers, no addresses.

Refrain from using PayPal, Venmo, eBay, Amazon.com, or other similar sites to collect payments

No posting girls' sales link on any public facing site, including private or closed group pages, including, but not limited to:

- Facebook Marketplace
- Facebook Buy/Sell/Trade Groups or Pages
- Neighborhood pages (i.e., Nextdoor)
- Craigslist, Offer Up etc.

Direct Shipping Information

Raspberry Rally is the new cookie, exclusive to Direct Shipping.



Direct Shipping Cost

- GSCTX will subsidize shipping for Direct Ship orders and cover 50% of the cost for customers.
- Customers must order minimum of nine packages for subsidized shipping to kick in.

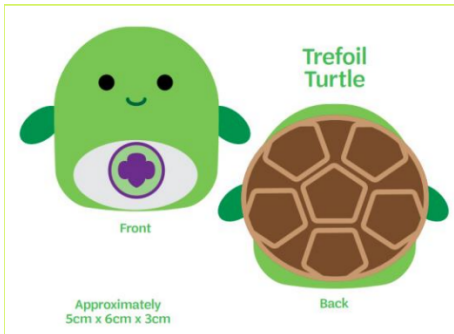
Troop Proceeds and Prizes
