What is the prescribed term for child support payments in the state of Texas?

According to section 154.001(1) of the Texas Family Code, the requirement for a non-custodial parent to pay child support typically ends when the child either turns 18 or completes their high school education, whichever happens last. The cessation of child support is ordinarily tied to the child's high school graduation, but it may be prolonged until the 18th birthday should the child graduate early. Additionally, child support can be extended beyond these conditions for children with special needs or disabilities to ensure their continued care.

Those with managing conservatorship hold the authority to make key life decisions for their children, covering areas such as health care, education, and religious practices. Parents may be appointed as either sole or joint managing conservators by the court, depending on numerous considerations. On the other hand, possessory conservatorship provides a parent with the ability to visit their children but does not include the power to make most of the child's decisions.
