MIDDLE SCHOOL FOOTBALL AGREEMENT – 2025

Overall Structure

MS 7th/8th Grade Football will conduct all practices at the facility located at Frenchtown Schools. Game schedules will be developed and maintained by Frenchtown Middle School. Changes in schedules will be communicated to Alberton Middle School. The head coach will establish practice schedules and communicate cancellations or changes to both the Frenchtown Middle School and Alberton Middle School administration. Uniforms will be provided by Frenchtown Middle School and will maintain the image, likeness, and color schemes of Frenchtown Middle School.

Governance Structure

As the primary sponsor of Middle School Football – The Frenchtown School Board and the administration of Frenchtown High School will be responsible for the cooperative program. Frenchtown High School will work directly with the administration of Alberton High School to address concerns. Parents of players from either school will be expected to follow Frenchtown School District's Policy 1700 for Complaints and Concerns.

Applicable Policies

Alberton Middle School students participating in Middle School Football at Frenchtown Middle School must meet the Academic Eligibility and Code of Conduct policies set forth by Alberton Middle School.

Coaching Personnel

Frenchtown School District will be responsible for the hiring, supervision, evaluation, and compensation of coaches.

Financial Procedures

Frenchtown School District will maintain all financial accounts related to the Middle School Football program and will be responsible for the payment of all game personnel. Frenchtown Middle School will retain rights to all revenue from ticket sales. Alberton High School students participating in the Middle School Football program will be responsible for payment of the \$30 activity fee assessed to each student participant.

Transportation

Frenchtown Middle School will provide bus transportation to and from each road event. Said transportation will only be provided from Frenchtown Middle School to the destination and will return to Frenchtown Middle School. Alberton Middle School will be responsible for transporting their students to Frenchtown Middle School for all road games. Alberton Middle School will also be responsible for all transportation of their students to and from Frenchtown Middle School for practices.

Supervision

Alberton Middle School is responsible for supervising Alberton Middle School students participating in Middle School Football at Frenchtown School District while it is transporting these students for practices and/or games to Frenchtown Middle School. Frenchtown School administrators and coaches shall be responsible for supervising Alberton Middle School students participating in Middle School Football at Frenchtown School District once they are on Frenchtown Middle School property for practices, games, or other activities associated with Boys Soccer as well as upon to and from Frenchtown Middle School and during all road events.

Insurance

Frenchtown Middle School will maintain insurance, in accordance with its current practices for all FTSD activities. Alberton Middle School maintains insurance. The parties agree to provide certification of coverage upon request.
