First Day of Preschool:

The first day of preschool for the academic year 2025-2026 is scheduled for August 12th, 2025.

Preschool Duration:

The preschool program will continue until May 29th, 2026, completing the academic year.

Program Details: The preschool program is a 4 half-day a week program. Weld RE-1 only offers an AM or PM 4-day session option only. Families cannot sign up for 1, 2, or 3 day preschool sessions only options, due to overall daily staffing needs. No reduction of tuition is made for illness, vacation or any other absence of the child.

Withdrawal:

If the parent/guardian decides to withdraw their child from the preschool program, a one-month notice must be provided in writing to the Preschool. Tuition fees for the one-month following the notice period will still be applicable.

Payments: Monthly cash or check submitted to Weld RE-1. Due no later than the 10th day of each month. Cash and Checks made out to Weld RE-1. All payments are submitted to the school office.

Returned Check Fee: \$8.00

Late Payment Fee: All payments after the 10th of each month will be assessed a \$25 late fee. The district reserves the right to end preschool enrollment for late payments.

Change in Programming: If the preschool age child qualifies and has an active Individualized Education Plan (IEP) for special education services or a change in the family's income or eligibility changes the family can apply for preschool at UPK.Colorado.gov.
