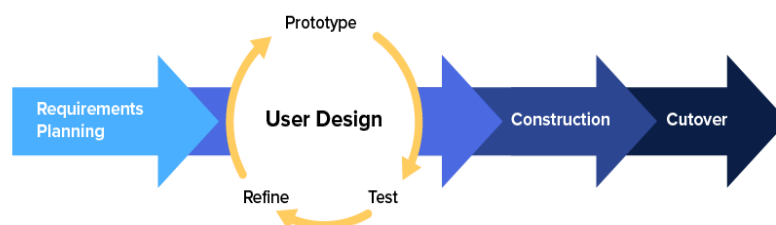


Figure 1 . Rapid Application Development (RAD) Model
