Vendor Move-Out Procedures

- Beginning at 5:05 p.m. on Saturday, vendors may begin packing up and moving out of the Beaumont Civic Center. Please return your Vendor Badges/Lanyards to a Junior League member, as we reuse them year to year.
- All Vendors must be fully moved out by 9:00 p.m. on Saturday.
- Please also don't forget to <u>return your evaluation form</u>. We appreciate your feedback and look forward to continuing to improve our market experience for you, the vendors, and shoppers.



PARKING: As with most businesses and retail establishments, customers will receive parking closest to the civic center. Trailers, RVs and any other vehicles belonging to vendors must be parked in an area designated for vendor parking. Parking will be monitored by Show Management and only one (1) warning will be issued to any vendor in violation. If the object/vehicle is not moved, it will be towed at the owner's expense. Please make arrangements to have your vehicle moved by you or a designee. Management does not have enough staff to accommodate nor will accept liability to move motorized or stationary objects for vendors. We will announce a shuttle to help move cars to the back lot one hour prior to market open.

Per your Vendor Contract, these parking guidelines will be enforced to ensure safety and efficiency to the retail customers. Vendors will need to park on Cypress Street near the North Parking Lot. We ask that you please complete this form, sign, and return this form to the vendor booth if your Vehicle Type/Color/License has changed since you submitted your contract. If you are bringing a different vehicle that previously noted please provide us with the license plate numbers to all vehicles, trailers, RVs, and any other vehicles you will be bringing to Main Street Market.
