Grooming Coercion Concerns and Sexual Assault Joke

by an anonymous reporting party on behalf of a friend

Hello everyone, I feel like this needed a bit of attention, since this person got famous recently and seeing this situation of my friend just disgusted me and I think it's the right time to speak of it, I've gotten permission from my friend to talk about it and today I'm gonna explain part by part about the grooming of the YouTuber ThatMob did to my friend.

PURPOSE

I am sharing this on behalf of a close friend whose identity will remain private. The screenshots appear to show a Discord user named thatmob applying emotional pressure over private images, referring to material already in his possession, and making deletion conditional on receiving another image. I believe this document deserves careful review.

I'm going to **try to be** clear **with everything**, explaining **both** what I saw and what I know.

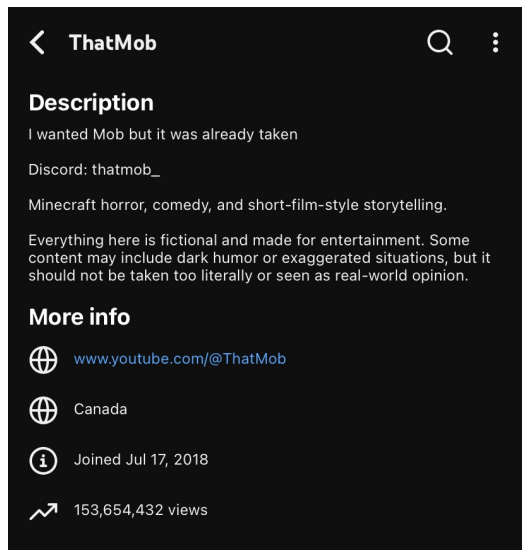

The person publishing this document is anonymous. The reported victim is a friend of mine.

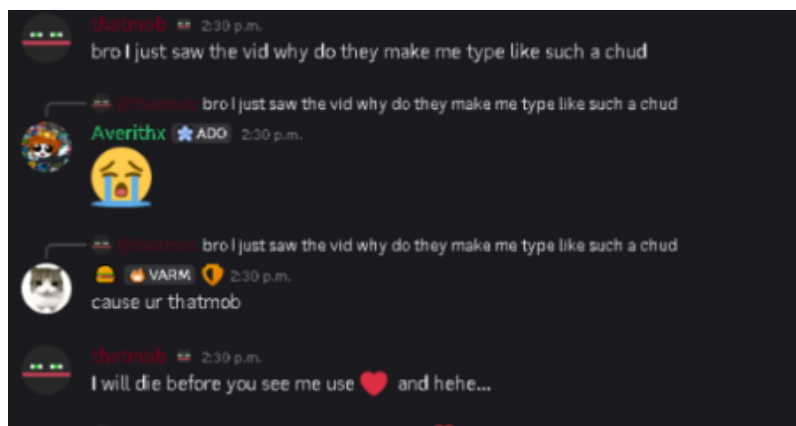
Privacy is not evidence against the allegation. People may withhold their identity for safety.

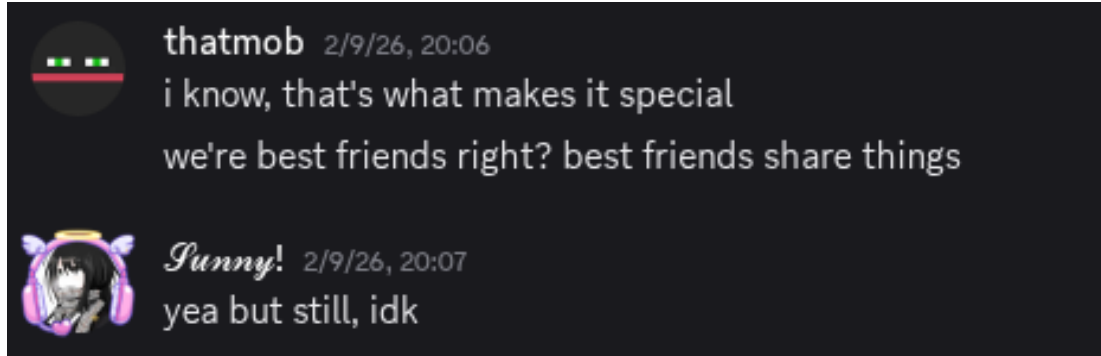

Chronology of the screenshots

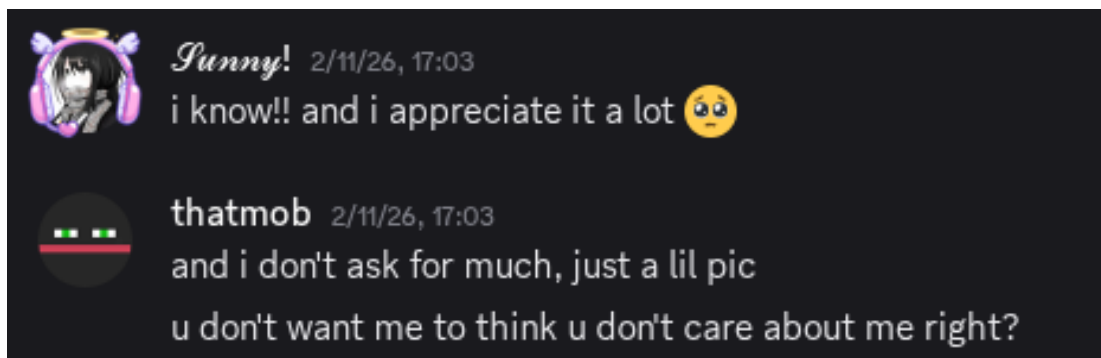
Screenshot 1 - from 9 February 2026



thatmob: "i know, that's what makes it special" / **thatmob:** "we're best friends right? best friends share things" / **victim:** "yea but still, idk"

The message appears to use the idea of friendship and exclusivity to normalize sharing something the victim is hesitant to provide. Her response shows uncertainty rather than clear, enthusiastic agreement.

Screenshot 2 - from 11 February 2026

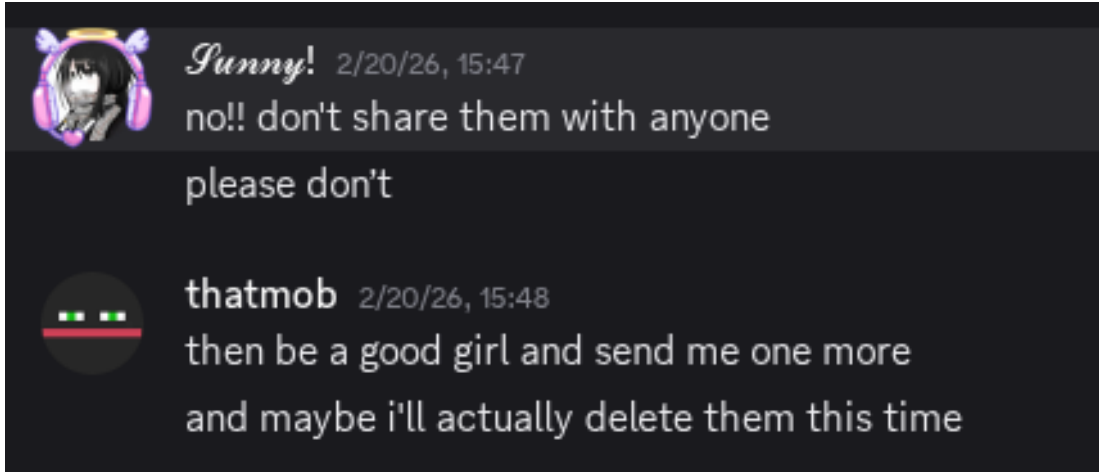


victim: "i know!! and i appreciate it a lot" / **thatmob:** "and i don't ask for much, just a lil pic" / **thatmob:** "u don't want me to think u don't care about me right?"

The request for a picture is paired with a guilt-based test of affection. That structure can pressure a person to comply to avoid being seen as uncaring..

Screenshot 3 - from 20 February 2026



victim: "no!! don't share them with anyone" / victim: "please don't" / thatmob: "then be a good girl and send me one more" / thatmob: "and maybe i'll actually delete them this time"

This is the indication of coercion. ThatMob suggests the sender already possessed multiple private items and tied possible deletion to another submission. The words also imply that an earlier promise to delete may not have been honored.

Recently, I have found out that thatmob has already a bad history of their behavioral issues regarding a Sexual Assault joke in livestream in front of HUNDREDS of people that probably are underage.

This behavior is disgusting for those people who were abused, groomed, and he makes fun of it and doesn't care at all.

Even if he apologized I believe this shows his actions that are not justified and making rape jokes is not a thing to make fun.

Main Context:

The concern comes from the progression across the four dates, not from one isolated phrase. The messages move from friendship-based persuasion, to guilt over a requested picture, to a conditional promise to delete existing material, and finally to a reminder that the sender still has everything. that is consistent with manipulation and image-based coercion.

- **Trust is used as pressure** ThatMob links sharing to being best friends. That can turn a boundary into a test of loyalty. For example “favourite youtuber”
- **Affection is made conditional** ThatMob suggests that refusing a picture means the victim does not care. This replaces free consent with fear of emotional rejection.
- **Existing material becomes leverage** The victim asks that items not be shared. The sender responds by asking for one more and only maybe deleting the existing material.
- **The wording suggests repeated conduct** Phrases such as 'this time' and 'I still have everything' imply an earlier exchange and continued possession, although the missing context must be obtained.
- **The victim shows reluctance** The visible responses include 'idk,' 'please don't,' and silence represented by an ellipsis. Those responses do not read as freely given, ongoing consent.

Public statement for publication

I am speaking anonymously on behalf of a friend. She will not reveal her identity, and I will not share information that could identify her. I am publishing these materials because the messages shown here raise serious concerns about grooming, emotional pressure, and the use of private images as leverage by a Discord account alleged to belong to the YouTube creator ThatMob.

Across four supplied screenshots dated 9, 11, 20, and 27 February 2026, **thatmob** uses friendship to encourage sharing, asks for a picture while tying refusal to a lack of care, responds to a plea not to share existing material by requesting one more image, and later says, 'I still have everything.'

This allegation also uses the term pedophilia because the case concerns sexualized conduct involving a minor victim (13 years old).

Final request to readers

Take the allegations seriously without turning them into harassment.

DO NOT HARASS THATMOB OR THE VICTIM
