 - Legislative Updates – Not a lot of work happening, a lot of distractions. Legislation on Apprenticeships, WIOA, etc are effectively stalled. Movement may start again

soon with federal appropriations for FY24 (late). If an appropriations bill is not passed when the current continuing resolution expires it may trigger a partial shutdown and another continuing resolution would include an automatic 1% budget reduction. Potential impacts of a shutdown or a triggered automatic 1% cut if an appropriations bill is not passed will not immediately affect most education funding as it is forward funded. Would impact next academic year funding. House and Senate vision for the budget are very different. Senate bill looks better for CTE with an increase in Perkins. The house bill includes a flat Perkins and a 30% reduction in other areas that will heavily impact education. ACTE is advocating for the Senate version.

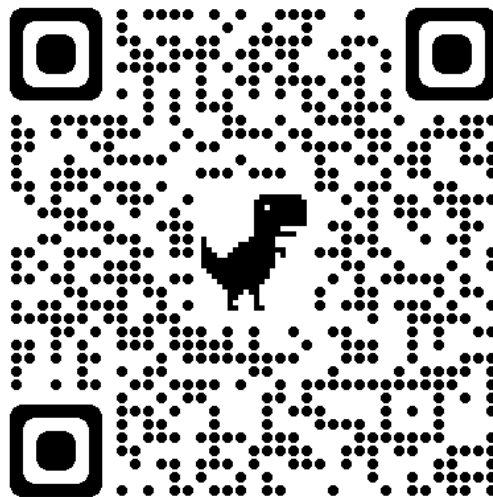
