Voting Delegates

Each chapter should choose one individual to serve as a Voting Delegate. It is recommended that this person not be involved in STAR Events, Knowledge Bowl, a tour, or FCCLA Serves as their schedule is very specific on Monday.

The following details the schedule for Voting Delegates on Monday, March 30:

- 12:45-1:15 Voting Delegate Sign-In
- 1:15-3:30 State Officer Candidate Speeches
- 3:30-4:30 Business Session
- 6:00-6:45 Cast ballot prior to Recognition Session at PBA

Voting Delegates will receive their nametag ribbon and official ballot upon check-in at the State Officer Candidate Speeches; upon check-in for the Business Session, Voting Delegates will receive their official business ballot. The nametag ribbon will serve as their clearance to cast their ballots on Monday, March 30 between 6:00-6:45pm at Pinnacle Bank Arena. If Voting Delegates do not sign in for either session, they will not receive nametag ribbons or official ballots and will not be eligible to cast votes.

There are multiple Bylaws amendments to be considered by voting delegates. These proposals are meant to clarify language and remove specific details, which should only be detailed in the Operational Procedures. Honorary Conference Assistants

Honorary Conference Assistants (HCAs) play a vital role in the operation and success of our annual State Leadership Conference. HCAs must be juniors or seniors in high school, have strong FCCLA experience and knowledge, previously attended an in-person SLC, and not be competing in STAR Events, Knowledge Bowl, or Skill Demonstration Events.

These youth personnel have the following responsibilities throughout the conference:

- Ensure correct A/V and room set-up for breakout sessions
- Assist with running STAR Event results
- Assist attendees in finding rooms
- Assist at the FCCLA Store
- Assist at the Opportunity Fair
- Assist at the SOC Speeches and Business Session
- Assist at the Knowledge Bowl
- Ensure individuals with assigned seating find their seats prior to sessions
- Ensure proper dress and tickets at dance (must attend the dance)
- Assist with line-up during the Competitive Event Recognition session

In exchange for their time, they receive a discounted registration rate, a free conference t-shirt, and three complimentary meals (lunch on Monday and Tuesday, supper on Monday).

Conference Assistants will receive their specific assignments at their mandatory Orientation Session hosted virtually on Wednesday, March 25 or Thursday, March 26 from 7-8pm CDT (date will be selected once assistants have been selected). Conference Assistants will need to arrive at the arena floor at PBA by 4:00pm on Sunday, March 29.

Members will be notified of their acceptance by February 16, 2026. Chapter advisers will be required to complete a Personal Profile Form, which will be sent automatically via Jotform once the student submits their application. Applications will not be considered complete until the Personal Profile Form has been completed and submitted.

Content Creators

As a Content Creator at the State Leadership Conference, you will be responsible for producing engaging and high-quality social media content tailored to members. This role offers a unique opportunity to develop your skills in content creation, social media management, and digital marketing while contributing to a dynamic and creative team. Ideal candidates are members with a passion for storytelling, creativity, and an understanding of various content formats.

The following requirements must be met for members to apply to be Content Creators:

- Strong FCCLA Experience and Knowledge
- Social Media/Content Creation Experience and Knowledge
- Previously attended an in-person SLC

In exchange for their time, they will receive a discounted registration rate, a free conference t-shirt, and three complimentary meals (lunch on Monday and Tuesday, supper on Monday).

Content Creators will need to arrive at the arena floor at PBA on Sunday, March 29 by 4:00pm.

Content Creator applications are due **Tuesday, February 10, 2026 at 5pm CST**. Members will be notified of their acceptance by February 16, 2026. Chapter advisers will be required to complete a Personal Profile Form, which will be sent automatically via Jotform once the student submits this application. Applications will not be considered complete until the Personal Profile Form has been completed and submitted.

Adult Volunteers

Advisers and chaperones play a vital role in ensuring the annual State Leadership Conference is a success.

Registration

All conference participants must wear a name badge in order to gain admittance into FCCLA SLC events. Everyone must register for the conference in order to receive a name badge, with the exception of competitive event volunteers who are assisting on Monday, March 30 and Tuesday, March 31.

Registration rates are set annually by the Nebraska FCCLA Board of Directors.

Tuesday Only Rate - \$50 | Tuesday

This rate includes entrance to all conference sessions as well as lunch on Tuesday.

SLC Youth Personnel Rate - \$35 | Sunday, Monday, Tuesday

Honorary Conference Assistants, Content Creators

This is a reduced registration rate, which includes a conference t-shirt, for the work of these members at the event.

Competitive Event Volunteer Rate - \$35 | Sunday, Monday, Tuesday (for attendance beyond volunteer role)

Adult Competitive Event Volunteers, Chaperones, Guests

This discounted rate includes entrance to all conference sessions and events on Sunday, Monday, and Tuesday as well as lunch on Tuesday. Competitive Event volunteers do not have to register for the conference if they are just volunteering on Monday (STAR Events) or Tuesday (Skill Demonstration Events). If they wish to attend any other events outside their volunteer role, then they need to register with this rate.

The following dress code shall apply to all state sponsored activities/sessions unless otherwise indicated by the Nebraska State FCCLA Adviser or Board of Directors.

Students attending sessions will be expected to wear the following attire:

- FCCLA official dress
- red, black, or white collared shirts with sleeves
**please note that the FCCLA logo is not a required component*
- neutral colored pants, capris, or skirts
**capris must fall completely below the knee; skirts should be no more than 2 inches above the knee at its shortest point*
- shoes, black preferred

The following are items that will not be allowed to any session:

- blue jeans, leggings, jeggings
- shorts or other athletic attire
- slippers, flip flops, slip-on sandals
- revealing attire, including but not limited to items that are low cut, tight, or see-through

Members will also be asked to remove outerwear (coats, sweatshirts, etc.) before entering. Members who are found in violation of the dress code at any point before or during a session will be asked to leave to change immediately. They will be more than welcome to return to the session when their attire meets the dress code requirements. Advisers and guests are asked to dress in business casual or business professional attire.

Examples could include Power of One projects, National Program projects, STAR Events, Feed Nebraska projects, fundraisers, etc. This event at SLC will not only provide a showcase opportunity for those participating, but it will also serve as a learning opportunity for those who stroll the projects.

Projects will be on display on Tuesday, March 31 from 9:00-11:00am in the second floor lobby at Pinnacle Bank Arena. Each project will have half of an 8' table and one chair; electricity will not be available. Participants will have time to set up displays between 8:15-9:00am.

Please note that Spotlight on Projects is offered at the same time as Skill Demonstration Events, RED Talks, and the Innovate the Plate experience. Chapters should ensure that projects are not left alone and have a representative available for the duration of the event.

Innovate the Plate: Power Up with My Plate

As a part of the USDA Team Nutrition grant at the Nebraska Department of Education (NDE), we are encouraging students and families to make a variety of healthy choices by following the dietary guidelines:

- Eat a variety of foods
- Eat more fruits, vegetables, and whole grains
- Eat lower-fat foods more often
- Get your calcium-rich foods
- Be physically active

This year, the Innovate the Plate culinary competition will allow students to select from two recipe categories to create and test healthy, My Plate-friendly recipes for the 2026 competition. [Access all information and guidelines for the Innovate the Plate competitions here.](#)

1. **[Beanstock](#)**: The recipe prototype formula(s) must use at least ½ cup of beans (canned or dried) and fit within one of the following menu categories: breakfast/main dish, savory snack/appetizer/side dish, or sweet snack/dessert.
Need ideas? Visit the [Harvest of the Month website](#) or the [Beanstock website](#) to view last year's winning recipe (scroll to the bottom of the page).
2. **[Team Nutrition Sports Nutrition](#)**: The recipe prototype formula(s) must be designed to support active students and athletes by providing balanced nutrition that fuels performance and/or recovery. Recipes should include nutrient-rich ingredients and ideally, include both a carbohydrate and a protein source. Recipes should fit within one of the following menu categories: breakfast/main dish, savory snack/appetizer/side dish, or sweet snack/dessert, and be easy for students to transport and eat to accommodate their busy schedules.
Need ideas? [Visit the Team Nutrition Sports Nutrition website](#). Sport-specific resources are available and provide ideas for snacks and meals to get your creativity flowing.

Participants must prepare a display board and their dish in person at the FCCLA State Leadership Conference on Tuesday, March 31 from 9:00-11:00am at Pinnacle Bank Arena. The prepared dish will be used for display purposes only. The Nebraska Department of Education will provide all equipment necessary to prepare and cook the recipes.

Participating schools will receive a stipend of \$150 to cover recipe development, storyboard supplies, and travel to Lincoln (up to two (2) teams per building). All food, supplies, and equipment will be provided by event organizers on-site for the recipe demo and presentation. This will include but is not limited to a large capacity air fryer, electric skillet, blenders, and mixer may be made available. Students will share their storyboards with judges and will be interviewed about the process used to select, test, modify, and prepare the recipe.

[Innovate the Plate Applications](#) are due by Friday, February 20 and only 20 applications will be accepted (just the original recipe before testing is due with the application).

Participants interested in participating in this event cannot be competing in Skill Demonstration Events, presenting RED Talks, or participating in Spotlight on Projects.

Competitive Events

Nebraska FCCLA offers four different competitive event opportunities as part of the annual State Leadership Conference. None of these state-level competitions are connected to the national competitive events described above, except STAR Events. We simply offer these opportunities at the state level to provide competition opportunities for members at SLC outside of STAR Events. Guidelines and more specific information about each event can be found in the [2025-26 Nebraska Competitive Events Handbook](#).

IEPs may be presented when students register if accommodations are necessary for their success in competitive events. This information will be shared with the event Evaluators and/or Lead Consultant. Advisers must complete the [FCCLA Participant with Accommodations Form](#) prior to the District STAR Event competition and by March 5 for all other competitive events.

Evaluators

Each chapter is required to submit evaluator names based on the number of STAR Event entries they have.

- 1-3 entries = 1 Evaluator
- 4-6 entries = 2 Evaluators
- 7-9 entries = 3 Evaluators
- 10+ entries = 4 Evaluators

These individuals can be FCCLA alumni, pre-service teachers in college, retired teachers, adults or college students familiar with FCCLA and/or other CTSO competitive events, etc. Chapter advisers and members who don't have experience competing in the event at the national level cannot serve as evaluators. We will provide the necessary training to willing volunteers who want to provide a high-quality experience for members.

The STAR Event Evaluator Orientation will take place on Monday, March 30 beginning at 8:30am in the assigned competition room. The competition schedule will be from 9:00am-4:00pm. The length of the assigned event will depend upon the number of participants; some events will not last the entire day.

Interested individuals should complete the [STAR Event Evaluator Interest Form](#) by February 28, 2026. Evaluators do not have to register for the conference, unless they wish to attend events outside of their volunteer role. STAR Event Evaluators will receive a complimentary lunch and a small gift of thanks for sharing their time and expertise as volunteers.

The Skill Demonstration Event Evaluator Orientation will take place on Tuesday, March 31 beginning at 8:30am in the assigned competition room in Pinnacle Bank Arena. The competition schedule will be from 9:00-11:30am. The length of the assigned event will depend upon the number of participants; some events may finish early.

If you have individuals with industry-specific knowledge and skills to assist as Skill Demonstration Event evaluators, please reach out to the Competitive Events team (competitiveevents@nebraskafccla.org) for a registration link.

Lead Consultants

Each district is responsible for submitting advisers to serve as STAR Event Lead Consultants.

These individuals will serve as the point person for an assigned room(s) or event(s); most Lead Consultants will have one room but could potentially have multiple events that take place in that room. They will assist the evaluators, keep the room on schedule, and finalize scores. Serving in this capacity will give chapter advisers an inside look at how specific events run and help them learn more; it's truly a unique way to learn more about a specific event!

All Lead Consultants & Room Consultants will attend the orientation on Sunday, March 29 from 2:30-4:00pm to review responsibilities, get familiar materials, and answer questions.

Chapter Advisers should complete the [STAR Event Lead Consultant Sign Up](#) by February 16, 2026. If you are interested in also serving as a Skill Demonstration Event Lead Consultant, please reach out to the Competitive Events team (competitiveevents@nebraskafcccla.org) for a registration link.

Competitive Event Youth Volunteers

Many volunteers are required to successfully host the state competitions. We are seeking youth volunteers who can assist with STAR Events or Skill Demonstration Events. These individuals will assist the event Lead Consultants throughout the competition, which will include serving as a timer or event runner. This is a great way for students to learn more about STAR Events or Skill Demonstration Events!

These individuals will need to be available for the entire day on Monday, March 30 or the morning of Tuesday, March 31. Lunch will not be provided for youth volunteers on Monday; light snacks will be provided.

You will be able to volunteer students for this role by completing the [Competitive Event Youth Volunteer Sign-Up Form](#) between Monday, March 16 - Wednesday, March 25 at 5:00pm CDT.

STAR Events

STAR Event competitions will be distributed between the Graduate and Pinnacle Bank Arena. A complete schedule will be shared with Chapter Advisers by March 10. Advisers should check these schedules for accuracy and conflicts as soon as possible and report any errors to the State Office.

STAR Event Registration

Names and events are submitted by District STAR Event Coordinators and are imported into the SLC Conference Registration system. Advisers will not have to register their students for STAR Events, but will need to review the registration to ensure that students are in the correct events. New this year,

Baking & Pastry and Culinary Arts competitors will also be registered for their respective event based on the results from the Qualifying Quiz.

The registration fees for STAR Events is outlined below:

- Baking & Pastry, Culinary Arts: \$20 per competitor (includes lunch)
- All Other Events: \$15 per competitor

Per the Nebraska FCCLA Operational Procedures, once registration is complete, competitive event fees are nonrefundable.

STAR Event Mandatory Sessions

STAR Event participants are required to attend three events. The first is the Participant Orientation on Monday, March 30 at 8:00am. The second is their actual presentation time. The third and final event is the Competitive Events Recognition Session on Tuesday, March 31, with participants finding their event seating by 11:50am; the session will begin promptly at 12:00pm.

In order for participants to receive their medal, they MUST attend this session. Medals and trophies will NOT be mailed to chapters after the event, unless there is a mistake. If a competitor is unable to attend this event, chapter advisers should pick-up the competitor's medal and/or trophy after the session has concluded.

Skill Demonstration Events

Skill Demonstration Event competitions will take place on Tuesday, March 31 at Pinnacle Bank Arena. A complete schedule will be shared with Chapter Advisers by March 16. Advisers should check these schedules for accuracy and conflicts as soon as possible and report any errors to the State Office.

Skill Demonstration Event Registration

There are limited spaces available for students to compete in Skill Demonstration Events, and all available spaces will be first come, first served as part of the SLC registration process. A waitlist for each event level will be established, and additional entries beyond the state capacities will be accepted, if there are Level(s) of an event that do not reach capacity. Chapters can have up to three (3) competitors in each event level. Students can only compete in one (1) event.

Skill Demonstration Event registration fee is \$10/competitor.

Per the Nebraska FCCLA Operational Procedures, once registration is complete, competitive event fees are nonrefundable.

Skill Demonstration Event Mandatory Sessions

Skill Demonstration Event participants are required to attend three events. The first is the Participant Orientation on Tuesday, March 31 at 8:00am. The second is their actual presentation time. The third and final event is the Competitive Events Recognition Session on Tuesday, March 31, with participants finding their event seating by 11:50am; the session will begin promptly at 12:00pm. If Skill Demonstration Event competitors are also STAR Event participants, they will sit in STAR Event seating and then remain backstage in Skill Demonstration Event seating after their STAR Event has been recognized. If a competitor is unable to attend this event, chapter advisers should pick-up the competitor's first, second, or third place certificate after the session has concluded.

FCCLA/LifeSmarts Knowledge Bowl

FCCLA/LifeSmarts Knowledge Bowl will take place on Monday, March 30 at the Graduate, and the third/fourth place and championship rounds will take place at Pinnacle Bank Arena on Tuesday, March 31. A complete bracket and match schedule will be shared with Chapter Advisers by March 28.

FCCLA/LifeSmarts Knowledge Bowl Registration

Chapters will register their Knowledge Bowl teams as part of the SLC registration process. Chapters may register up to two (2) teams. Teams are made up of five (5) members; team members may not be STAR Event competitors. Teams will collaboratively take a 50-question quiz during the testing window, February 5-13, 2026. The 12 teams with the highest scores will be invited to compete in the head-to-head competition at SLC; announcement of the Top 12 teams will be made by Monday, February 16.

FCCLA/LifeSmarts Knowledge Bowl registration fee is \$20/team.

Per the Nebraska FCCLA Operational Procedures, once registration is complete, competitive event fees are nonrefundable.

FCCLA/LifeSmarts Knowledge Bowl Mandatory Sessions

FCCLA/LifeSmarts Knowledge Bowl participants are required to attend a Participant Orientation on Monday, March 30 at 1:00pm. Following the orientation, team members must remain at the Graduate to compete in the head-to-head matches, which will take place on a rolling basis.

FCS Challenge Tests

The FCS Challenge Test online testing window will be Wednesday, March 11 at 7am CDT through Friday, March 20 at 6pm CDT.

FCS Challenge Tests Registration

FCS Challenge Test registration will occur as part of the SLC registration process. Students can take as many tests as they like.

FCS Challenge Test registration fee is \$5/test.

Per the Nebraska FCCLA Operational Procedures, once registration is complete, competitive event fees are nonrefundable.

FCS Challenge Tests Mandatory Sessions

Students who place in the top three will be recognized on-stage at SLC during the Opening General Session on Sunday, March 29. Participants who are in the top three will be shared with other award notifications by March 25. Finalist certificates will be awarded to the first, second, and third place finishers on-stage.

Parking

Large vehicles, vans and buses may park at the Festival Lot at Pinnacle Bank, free of charge and then be shuttled by the Graduate shuttle. Please note that drivers should drop off their students at the hotel, rather than having a large group ride the shuttle back. The Festival Lot is located directly north of the Pinnacle Bank Arena.

Hotel Reminders & Safety

There are more people staying in these hotels than just FCCLA members. Please remind members that the other guests make first impressions about the student, school, and our organization based on what they see and hear in the hallway, on the elevators, and in the lobby. Encourage your members to represent FCCLA positively by dressing and acting professionally.

The following are guidelines and suggestions to keep in mind to keep you and your students safe at SLC.

- Make sure you have a list of who is staying in each hotel room and what their room number is.
- DO NOT post students' names on the outside of their hotel doors.
- Ensure students keep their doors completely shut and NEVER put the lock out to keep their door open.
- Hotel fixtures must stay in their original location and not be moved out of, or around a room.
- All students will observe quiet hours and the 12:00am midnight curfew.

Success at SLC

Chapter advisers are responsible for the behavior and discipline of their students throughout the conference. Students causing a disturbance or displaying inappropriate behavior will be asked to leave the conference and/or hotel. In addition, if any issues are witnessed, chapter advisers are encouraged to speak directly to the students' chapter advisers to address the issue. All conference attendees should be informed of the following:

- All conference participants must wear a name badge in order to gain admittance into FCCLA events. Everyone must register for the conference in order to receive a name badge.
 - Conference name badges should be removed when walking between conference venues.
- Behavior at all times should reflect a positive, professional image of you, your school and the organization.
- Any accidents, injuries, or illness should be reported to the adult chaperone or chapter adviser immediately. State staff should be informed of such incidents as well.
- While the Haymarket, Railyard, and Downtown areas are very safe, students should always travel with at least one other individual.
- Pay attention to traffic signs and flow. Many streets become one-way once you enter the downtown area. Most streets in the Haymarket area are 2-way. Use crosswalks and follow all crosswalk signals at all times
- If a student is found responsible for stealing or vandalism, the student and his/her parents/guardians will be expected to pay for damages.
- Students may not purchase, possess, consume, or be under the influence of alcohol, tobacco, or drugs at any time.

Nebraska FCCLA does not have a set requirement for a chaperone to student ratio. However, a recommended ratio is 1 adult to every 15 students. Chapter advisers are encouraged to seek clarification from their local school administration or activities director.

CTSO Medical Release/Personal Conduct Agreement Form

All chapter advisers are required to have a completed [CTSO Medical Release/Personal Conduct Agreement Form](#) on file with them for every student traveling under their supervision. These forms must be signed by parent/guardians to be valid. These forms will not be collected at the event, but are essential for advisers to have, if there were to be any type of emergency situation. If the local school or district has an alternative form, that form can be used instead of the form provided. However, it's important for the chapter adviser to ensure that the local form has the same information/elements as the form that's provided.

Chapter advisers will confirm during the SLC registration process that they have collected these forms for all students attending the conference.

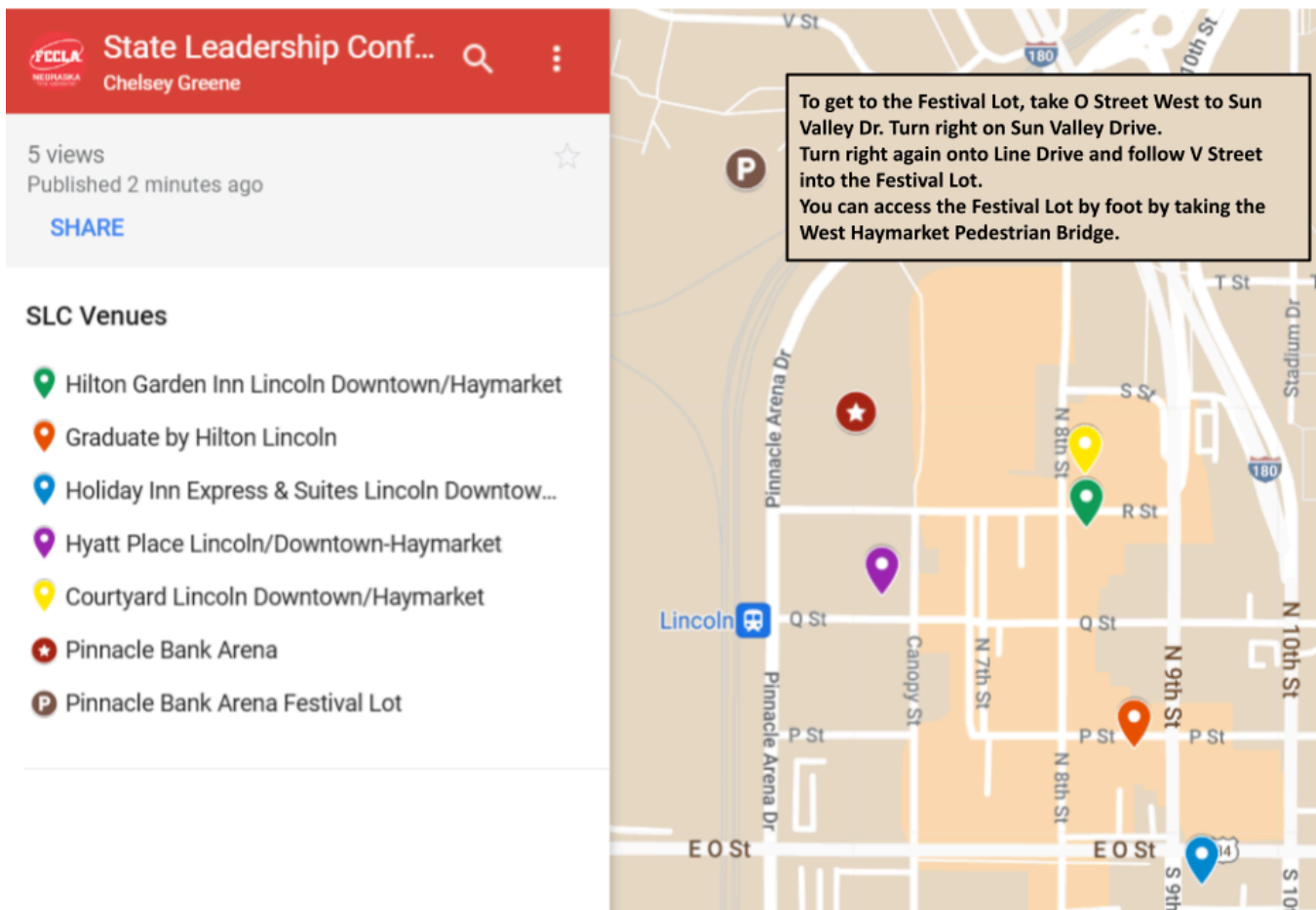

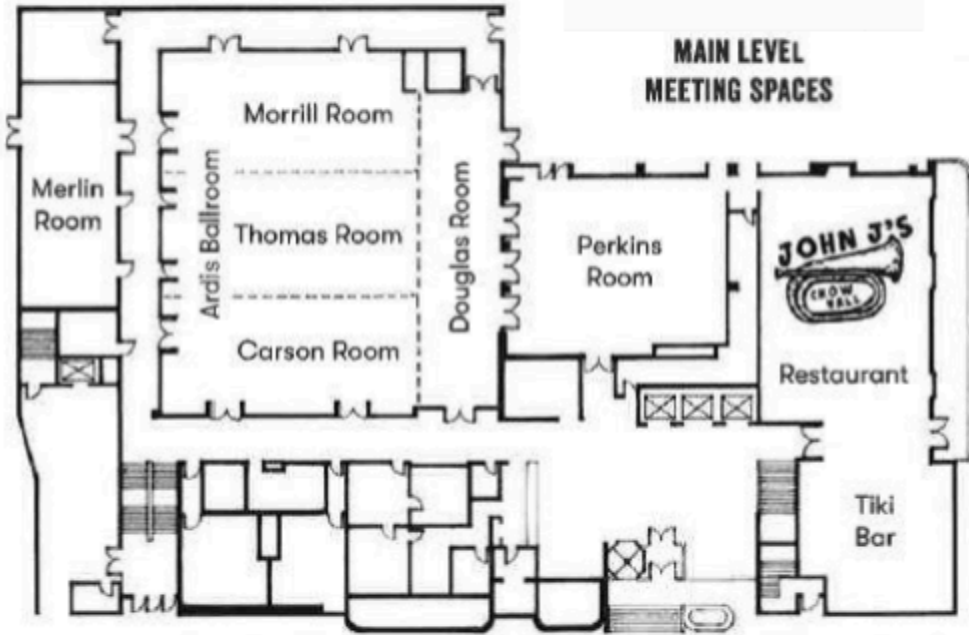

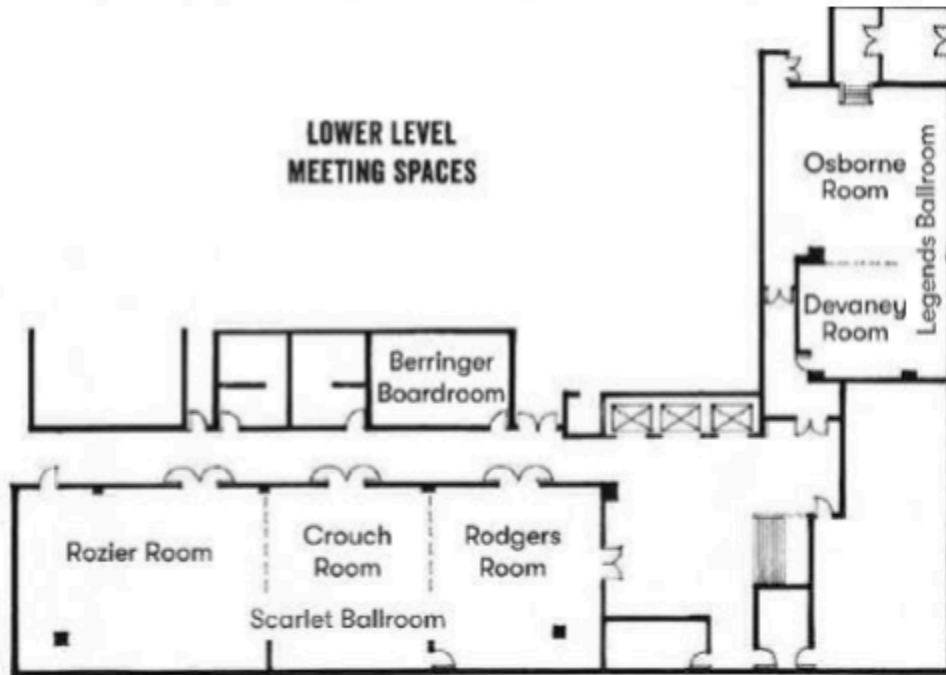
Graduate Hotel Map
