By commissioning me, you are acknowledging that you have read and agreed to the terms below.

These terms are subject to change.

GENERAL

- You must be 18+ to commission me.
- Under no circumstances do I permit my work, commissioned or personal, to be used or associated with NFTs, cryptocurrency, the blockchain, or AI art/training.
- I reserve the right to publicly post and display all commission work. I do not offer private commissions.
- Failing to comply with any of the terms listed in this document can result in the cancellation of your commission, as well as you being blacklisted in the future.
- I have the right to turn down commission requests for any

reason.

PAYMENT

- Payment must be made in full before work is started on your commission.
 - For more expensive pieces (\$200+ USD), payment plans can be discussed upon request.
- I accept payment via PayPal only. A valid email address is required for me to send an invoice once you have been added to my queue.
- In the event of a cancellation initiated by the client, a partial refund proportionate to the amount of work already done will be discussed.
 - Cancellations initiated by myself will be refunded in full unless otherwise agreed upon by the client.

USAGE

- I retain full copyright over all commissioned artwork. This includes (but is not limited to) the right to display finished pieces as commission examples and other self-promotional material.
 - I will never commercially redistribute commissions (i.e. selling them as prints or other merchandise) unless specifically asked to by the client.
- You may repost your commission wherever you like as long as I am credited. Linking back to the original post in my gallery or on Twitter is appreciated, but never required.
- You may not claim my artwork as your own.
- You may not resell my work or use it commercially.

SUBJECT MATTER

WILL DRAW

- Anthro / furry
- Feral / quad
- Monsters / fantasy creatures / etc.
- Copyrighted/canon fictional characters

WON'T DRAW

- Excessive or extreme gore
- Characters labeled with transphobic slurs or otherwise offensive terms (f*ta, tr*p, h*rm, etc.)
- Illegal content
- Hateful content (depictions of racism, homophobia, transphobia, etc.)
- Complex machinery
 - Robotic characters may be accepted depending on complexity
- Certain kinks (please ask first!)
- Suggestive art of underage characters / characters that appear to be young (asking for this will result in you immediately being blacklisted.)

NSFW and kink-related commissions are taken on a case-by-case basis.

If you're unsure about whether or not I'll draw something, please don't hesitate to ask!

PROGRESS & TURNAROUND TIME

- WIPs are provided during various stages throughout the commission process (i.e. sketch, lineart/refinement, base colors).
 - I will wait for each WIP to be approved by you before continuing work. Please let me know of any changes you want made throughout this process.
 - Requests for major alterations after WIPs have already been approved may be declined or subject to additional fees.
- Information regarding your commission (including your current place in my queue) can be found on my [Trello](#).
- Turnaround times can vary. I try to finish commissions no longer than 30 days after they have been fully paid for, but it may take longer depending on my health and your position in the queue.
