

#### Discussion:

The Salt Lake City Field Office has encountered limitations and restrictions related to its ability to enforce the Immigration and Nationality Act and Chapter Eight of the Federal Code of Regulations due to terminations of intergovernmental service agreements with ICE by the Utah County Sheriff's Office in August 2016, Cache County Sheriff's Office in November 2022, and the Washington County Sheriff's Office on May 31, 2023.

These terminations have ended ICE's ability to detain foreign nationals on a long-term basis (over 72 hours).

In fiscal year 2023 (October 1, 2022 – April 30, 2023), the Salt Lake City Field Office arrested 4,216 foreign nationals of which only 33%, or 1,396, were detained by ICE, the other 67% were released from ICE custody. Non-detention policies stemming from local sheriffs' offices directly resulted in the exceptional number of foreign nationals released back into the community to reside alongside Utah residents.

These non-detention policies have compromised the Salt Lake City Field Office's ability to support the U.S. Border Patrol and their efforts to stem the current border surge by providing the Department of Homeland Security additional bed capacity to detain and remove inadmissible foreign nationals. It is also providing a pull-factor from the border to the region as foreign nationals have provided intelligence to staff advising that word of mouth amongst migrants is that Utah is a location where they will likely not be deported. The field office is also observing migrants who recently crossed the border are relocating from sanctuary states like New York and Illinois to Utah due to the lessened risk for deportation.

Additionally, the bed terminations have also directly de-stabilized ICE's law enforcement capability in the States of Idaho and Montana as Utah-based bed space provided a central location for detainee transfers for those arrested by ICE and the Border Patrol on the northern border. Additionally, due process for foreign nationals has been degraded as those in immigration proceedings no longer direct access to Immigration Judges based in Utah who are responsible for hearings in Idaho, Montana, and Utah in an expedited detained setting. All hearings are now conducted in a non-detained setting, increasing hearing wait times from one to three months, in a detained setting, to two to five years due to lack of bed space for detained hearings.

### Designation:

Accordingly, due to the de-stabilization of ICE's law enforcement mission in Idaho, Montana, and Utah, its negative downstream impact to the Border Patrol and border security, along with compromised due process and restriction of speedy immigration hearings, and the fact that other sanctuary states such as Colorado Illinois, Maryland, Washington, etc., have enacted similar non-detention policies, I am designating the State of Utah as a sanctuary state.

#### Overview:

- Major local sheriffs have enacted soft-bans/sanctuary policies on immigration detention, terminating all long-term detention contracts with ICE Enforcement and Removal Operations (ERO) Salt Lake City.
- This has resulted in approximately 70% of the field office's arrests being released from custody.
- It has also destabilized ERO Salt Lake City's capability to support the Border Patrol's Havre Sector in Montana along with CBP's international screening activities at airports.
- ERO Salt Lake City and ICE Headquarters' officials have met with various Utah elected leaders since 2016 regarding lack of detention space in the region with no advancement on this issue.



Grassroots Utah State Flag Initiative Challenges Cease-and-Desist from Lieutenant Governor, Alleges Constitutional Freedom of Speech Violation

Utah, Nov. 13, 2023 – Tracie Halvorsen, a sponsor of the Restoring the Utah State Flag Initiative, a grassroots movement dedicated to giving a voice in the decision to change the Utah State Flag, has issued <u>a response</u> to a <u>cease-and-desist letter</u> received from Lieutenant Governor Henderson's office. The cease-and-desist letter was issued following a reaction to the grassroots public statement on the platform referred to as "X" (formerly known as Twitter), which included the use of the Initiative's <u>State Flag Initiative logo</u>.

On October 25, 2023, Lieutenant Governor Henderson made a <u>public statement</u> on the "X" platform, expressing gratitude to SaveUtahsFlag, an account in opposition of the grassroots movement. This statement was in response to their report of an alleged "unauthorized Great Seal usage", indicating Lieutenant Governor Henderson's intent to issue a cease-and-desist letter.

Halvorsen's response raises concerns over Lieutenant Governor Henderson's interpretation of <u>Utah Code 67-1a-7</u>. Halvorsen contends that this interpretation grants unchecked authority to Lieutenant Governor Henderson, providing broad authority to determine what constitutes the "Great Seal of this state" and the essential elements of the Utah state flag. Halvorsen believes this interpretation provides for an abuse of power allowing Lieutenant Governor Henderson discretion, which results in a potential infringement on the constitutionally protected freedom of speech.

Halvorsen contends that this rule is specifically designed to govern the usage of the Great Seal by government officials and government employees in their official communications and activities. It does not extend its scope to regulate the general public's use of the Great Seal or use of any variation of symbols. Instead, it emphasizes the importance of ensuring the proper and authorized use of the Great Seal by government entities for official state purposes. The reason behind this limitation is to prevent any potential misuse or abuse of the authority granted to those individuals in their official capacity.

Halvorsen indicates that this interpretation finds further support in the historical context of its application and its placement within the Utah Code, which is titled "State Officers and Employees." This placement reinforces the notion that the rule primarily pertains to governing the conduct of state officers and employees when dealing with the Great Seal in their official

Halvorsen asserts the adoption of the grassroots State Flag Initiative logo represents collective frustration with Lieutenant Governor Henderson's handling of the grassroots state initiative and the growing sentiment that representatives are not listening to the voices of "We the People." Halvorsen contends the demand to discontinue the use of the Initiative's logo is an infringement upon their constitutionally protected freedom of speech.

Halvorsen goes on to reference legal precedent, including the case of Rothamel v. Fluvanna Cty., to highlight concerns about content and viewpoint censorship and the potential abuse of power when discretion of a government official influences who can speak. Halvorsen firmly maintains that this concern gains further credibility through <u>Lieutenant Governor Henderson's public statements on the X platform</u>, which seem to exhibit a noticeable bias. This bias appears to unfairly target the Utah Flag Initiative logo, while overlooking other groups utilizing the same symbols. Halvorsen argues the symbols integrated in the State Flag Initiative logo are clearly integral components of the Utah flag, which the Lieutenant Governor clearly states "There is no problem using all or part of the state flag." However, Lieutenant Governor Henderson is demanding the logo's discontinuation and threatening potential felony charges to be pursued against innocent citizens.

Halvorsen further highlights an observation of Mallory Underwood, the author of the cease-and-desist letter, who appears to utilize a "seal" in her email signature block that does not align with the parameters prescribed by the legislative code <u>UCA 67-1a-8</u>. Halvorsen maintains that the legislature has not granted the Lieutenant Governor the authority to craft personal seals for official use and communication, "evoking a sense of 'rules for thee, not for me' sentiment."









# Iron County Republican Party calls on Governor Cox to Rescind Divisive, False, & Inflammatory Statements 3 min read

#### May 2, 2024

At the 2024 Republican State Convention, Governor Spencer Cox insinuated that Delegates who don't vote for him "hate too much," and stated that those Republicans are "radical extremists." He threatened that if we didn't vote for him the Republican Party would lose the Neighborhood Caucus-Convention System, which allows everyone an equal chance to participate in our elections regardless of their financial situation. In a follow up fundraising email, he doubled down on this divisive and contentious rhetoric.

We are concerned that this negative approach will only increase when the campaign shifts from talking to delegates in person to third party paid advertising, and that the countless time and resources that volunteer delegates spend taking their roles seriously will continue to be disrespected.

Governor Cox took these actions in response to a portion of the State Delegates expressing their dissatisfaction with his actions in office by booing him at the beginning of his speech. While we do not approve of booing as an effective form of communication with our representatives, Spencer Cox's response was no better, and as the governor, and as a Republican leader, Republican voters expect better leadership.

We are confident that if Governor Cox had given a more positive and unifying speech, explained some of the disagreements better, did not collect signatures, and spent more time visiting places like Iron County in person that he would have received a significantly higher vote than the 29% he received. These common-sense approaches to campaigning were done by most of the other candidates who received better results. Senator Orrin Hatch in the 2012 election, whom Governor Cox referenced in his speech, campaigned well and received nearly 60% of the vote despite controversial votes taken. Representatives Moore and Maloy both easily qualified for the primary ballot without the need for collecting signatures.

Delegates are elected by their neighbors. Most delegates are respected by their neighbors through their community service, employment, positions on issues, or ecclesiastical positions. If they weren't respected and representative of their neighborhoods, then they would not be elected.

If non-delegate voters were given the same amount of <u>time</u> and <u>availability</u> to candidates as delegates receive, we are certain that the broader primary electorate would make essentially the same decisions in Party Primary Elections as the Delegates do in Party Conventions.

Unfortunately, with the broad disparities in access to money that various candidates have, equal access to voters is not possible for all candidates. This is the most likely cause of any significant disparity in results between convention and primary, and until scientifically replicable research is completed, it is not philosophically cogent to simply label the difference in outcomes to what Governor Cox prescribed – delegates "hate people" and are "extreme and radical".

In 2020, during the Republican primary with three other candidates, Governor Cox received 36% of the vote, only 2% higher than the next highest candidate. This 36% primary result is not significantly different from the 29% of State Delegates that voted for him at the Convention.

It is critical that Governor Cox work to positively reach out to the 64% of Republicans who voted for another candidate and work to unify our party in order to establish and promote Republican values.

We call upon Governor Cox to disagree better, to rescind his divisive, false, and inflammatory remarks, and to apologize to the Utah Republican Party organization, the Republican voters of Utah, and the duly elected volunteer State Delegates who represent them on the local level.

1. The entire state is now under a mask mandate.



- You must wear a face mask indoors and outdoors anytime you are within 6 feet of anyone from another household. This means you must wear a face mask anytime you are around people you don't live with.
- Customers, patrons and employees of businesses must wear a face mask.

Even after the orders issued today expire, the mask mandate will be extended for the foreseeable future.

2. Casual social gatherings are only allowed with people you live with until November 23, 2020.



This does not apply to work, school or religious services, where masking and physical distancing are already enforced.

You should cancel plans with extended family and friends for the next two weeks. Telework if you can. Businesses and restaurants are not shut down because of this, but if you go out to eat, it should only be with people from your home.

3. All school extracurricular activities, sports and clubs are on hold for the duration of the <u>orders.</u>




- No organized or school-sponsored extracurricular activities, including sports and intramural events. Currently scheduled high school football games are allowed to continue with increased restrictions.
- No private, recreation, or club sports and athletic events.
- After November 23, 2020, it is anticipated weekly testing of participants in high school sports will be implemented.
- Intercollegiate sporting events are allowed due to already enforced health requirements.

4. College students, who either live on campus or attend at least one in-person class per week, are required to be tested for COVID-19 weekly.



- K-12 schools are open for in-person learning.
- College and university students who live on campus or attend an in-person class will be tested for COVID-19 each week.
- Testing is encouraged to begin as soon as possible, but must be implemented by the beginning of spring semester.

"Don't yell at the clerk; don't yell at the store manager," he said during a news conference on Thursday. "Don't make a fool of yourself because you don't want to wear masks."

He urged Utahns to consider their risk level and said those who haven't been fully vaccinated when the mask mandate ends should consider continuing to wear a mask or not go out. 

State employees were told Wednesday they'll have to keep wearing masks through the end of May, Cox said, an example he encouraged other employers to follow since they, too, have "the ability and, I would say, an obligation," to keep workplaces safe.

"We want to make sure our employees all have an opportunity to get that vaccine before we take the masks away," he said, adding it will likely take until the end of May before everyone who wants to be vaccinated is able to get a shot.
