4. Third Parties and Advertising Cookies

Third parties, including Google and its advertising partners, use cookies to serve advertisements on our website based on your prior visits to the website or to other websites, and to provide you with relevant advertisements when you visit the website. You can control the use of cookies in your browser to disable this feature, though it may affect your use of this website or other websites.
