

How many people with various disabilities are there?

Most of the current statistical information about people with disabilities is provided by the Participation and Activity Limitation Survey (PALS 2001; 2006). PALS is a national survey designed to collect information on adults and children who have a disability, that is, whose everyday activities are limited because of a condition or health problem (Statistics Canada, 2006).

The 2006 PALS, the totals include the Yukon, Northwest territories, and Nunavut, for a total of 4.4 million Canadians or 14.3% of the population are people with disabilities. The percentage in British Columbia of people with disabilities is 638,640 or 16% in 2006 (Statistics Canada, 2006).

Due to the amenities and weather, it is reasonable to infer this percentage would be higher in Vernon, possibly 18%, due to the high number of seniors in the region. Therefore, IL Vernon reasonably estimates that in Vernon (population 55,000) there are approximately 9,000 to 11,000 people with disabilities in Vernon.

Parking permits for people with mobility disabilities verify the person is unable to walk a 100 meters. IL Vernon is one of seven agencies in the province who issue the parking permits. Currently, IL Vernon has 4,425 active permits issued to residents in Vernon. In addition, there are approximately another 4,500 permits issued to residents of, Coldstream, Lavington, Lumby, Cherryville, and Armstrong. Total: 8925 permits in the North Okanagan issued by IL Vernon to people with disabilities that limit their mobility.

In Canada, there are 4,417,870 people with disabilities, and 2,946,160 have mobility disabilities in Canada (67%)
