the present contract is concluded.

I.SUBJECT OF THE CONTRACT

The CLIENT assigns and the CONTRACTOR accepts to educate the child:

PERIOD, in accordance with the provisions of the Education Act and other regulations in the education system, the State Education Standards and the protection of life and health of students, for an annual Tuition and Maintenance Fee.

II.CONTRACTOR'S RIGHTS AND OBLIGATIONS

Art 1 The CONTRACTOR shall:

- (1) Provides the necessary conditions for the full development and education of the child in a full-day organization.
- (2) Ensures implementation of the State Education Standards.
- (3) Creates conditions to protect the life and strengthen the health of the child.
- (4) Recruits qualified teachers to implement its strategy.
- (5) In the case of admission of children with physical and mental developmental disabilities, the regulations described in Article 5.2.14 of the GENERAL CONDITIONS shall be followed.



(6) Ensures the protection of personal data made known in connection with the performance of the obligations under the contract, in accordance with the Personal Data Protection Act and EU Regulation 2016/679.

(7) Provides students with free use of state-funded activities once the school is included in the state funding system.

(8) Any other obligations described in the GENERAL CONDITIONS.

Art. 2 The CONTRACTOR shall be entitled to:

(1) To obtain full and reliable information about the personal data, health and habits of the child, including physiological or other personal characteristics (including individual educational needs, difficulties in physical, cognitive, linguistic, social, sensory, emotional, creative development of the STUDENT in relation to children of the same age group) at the time of admission.

(2) Receive the stated Annual Tuition and Maintenance Fee in accordance with the terms and conditions agreed to in Section III of the GENERAL CONDITIONS and PAYMENT PLAN, an integral part of the Contract.

(3) All other rights described in the GENERAL CONDITIONS.

III. RIGHTS AND OBLIGATIONS OF THE CONTRACTING AUTHORITY

Art 3 The CLIENT shall have the right to:

(1) Receives information about the child's development and learning outcomes.

(2) Attends celebrations and open lessons at the invitation of the school.

(3) All other rights described in the GENERAL CONDITIONS.

Art. 4 The CLIENT shall:

(1) State in writing your child's wish to attend the school.

(2) To give full and reliable information about the personal data, health and habits of the child, including physiological or other personal characteristics (including individual educational needs, difficulties in physical, cognitive, linguistic, social, sensory, emotional, creative development of the STUDENT in relation to children of the same age group) at the time of admission.

(3) To assist in the preparation of the child's individual programme.

(4) Submit the following documents the day before your child's admission:

1. Child's health card completed by the GP.

2. Certificate of Completion of Education / Kindergarten or relevant previous grade/ if applicable.

3. Transfer certificate / issued by the previous institution/ if applicable.

(5) Accepts the style and principles of organization of the educational process in the Private Secondary School "Democratic Education Varna".

(6) Ensures the child's attendance, according to the organization of activities in the school.

(7) Informs teachers or administration of the child's upcoming absences, the duration and reason for them.

(8) Pay an annual Tuition and Maintenance Fee in accordance with Section III of the GENERAL CONDITIONS and PAYMENT PLAN, an integral part of the Contract.

(9) Any other obligations described in the GENERAL CONDITIONS.

IV. ANNUAL TUITION AND MAINTENANCE FEE

Art. 5 The annual fee has been calculated according to the Mechanism for Distinguishing Expenditure Financed by the State Budget. It includes the cost of remuneration of teaching and non-teaching staff for activities outside the compulsory curriculum, including compulsory employer contributions; provision and maintenance of physical facilities, including major and current repairs; equipment; costs of non-current assets; depreciation of fixed and non-current tangible assets; costs of



water, fuel, energy, materials and consumables for activities outside the curriculum; sanitary and hygiene materials; and e

- Building on activities in areas of interest from the curriculum;
- Personal mentoring program;
- Activities outside the school grounds within the city of Varna;
- Additional work with bilingual and non-native speakers;
- Additional support programme for students with outstanding gifts;
- Activities related to arts and crafts - dance, theater, applied arts, organization of workshops, participation in exhibitions, competitions, festivals, etc.;
- Sports activities for the formation of skills for tolerance, teamwork, striving for a healthy lifestyle;
- Additional interest activities.

Additional costs to be paid by parents over and above the annual fee if requested:

- Nutrition;
- Transportation.

Art. 6 The transport fee is payable separately at the parent's request, in accordance with the PAYMENT PLAN, an integral part of the contract.

Art. 7 The annual tuition fee is paid in BGN by BANK ROUTE to an account at **UNITED BULGARIAN BANK AD.**

V.LIABILITY IN CASE OF NON-PERFORMANCE AND TERMINATION OF THE CONTRACT

Art. 8 The Contract may be terminated in the cases described in Section IV of the GENERAL CONDITIONS.

Art. 9 Upon termination of the Contract on the grounds described in Section IV, Article 4.2 of the GENERAL CONDITIONS, the CONTRACTOR shall reimburse the CLIENT the balance of the tuition and maintenance fee paid.

VI.ADDITIONAL CONDITIONS

Art. 10 Any uncertainties arising during the performance of the contract shall be settled by contact and discussion between the parties. Amendments and supplements to this contract shall only be valid if made in writing and signed by both parties.
