About this notice

This privacy notice explains what personal data we collect from or about you.

It sets out why we collect, use, and protect your personal data, and what rights you have over that data.

The personal data that we collect is used to provide our users access to, and improve our network. We will not use or share your information with anyone except as described in this privacy notice.

Who we are and what we do

Harvard Kennedy School Women's Alumni Network (HKSWAN) is a volunteer-run non-profit (501c3) led by Harvard Kennedy School (HKS) alumnae. We operate the https://www.hkswomensnetwork.com/ website and send newsletters to our members, which provides a connection to HKS alumnae.

The mission of the Harvard Kennedy School Women's Alumni Network (HKSWAN) is to connect, support and amplify the efforts of HKS women and gender nonconforming individuals in authentic, meaningful, and powerful ways.

How we collect and use your information

How we collect and use your personal data will depend on how you interact with us. To better understand how and why we use your data, please refer to the category below that best describes you.

I am just browsing your website

If you are just browsing our website, we may collect your data using cookies or other tracking technology which.

Log Data

We want to inform you that whenever you visit our site, we collect information that your browser sends to us that is called Log Data. This Log Data may include information such as your computer's Internet Protocol ("IP") address, browser version, pages of our site that you visit, the time and date of your visit, the time spent on those pages, and other statistics.

Cookies

Cookies are small text files that are placed on your device, such as your computer, phone, or tablet, when you view pages on our website. These cookies allow us to track some of your browsing preferences and optimise how the website works.

While we are not looking to identify you using cookies as the focus is on your device, it may be possible for us to identify you or infer information about you. You have the option to either accept or refuse these cookies and know when a cookie is being sent to your computer. If you choose to refuse our cookies, you may not be able to use some portions of our Service.

Members in the UK or EU

Under UK and European data protection law, there is some additional information that we need to provide to you about what we do. You can find this information set out below.

Our role

We are the "controller" of the personal data we process. This means that we are responsible for deciding how we collect, use, and store information about you.

What allows us to use data about you?

We are only able to use your personal data when the law allows us to. This is called the legal basis. Regarding the above reasons for using your data, the legal basis we rely on are listed and explained below:

Consent – When we send you newsletters, we only do this when you have given us your consent to do so. This will be explained to you when you register to join the network or subscribe to the newsletter. You have the right to withdraw your consent at any time. To do so you can unsubscribe on the link provided in the newsletter.

Contract – When you join our network, register for an event, or donate to our network, we need to use your data to fulfil that contract you have with us.

Legitimate Interests – If you have received an invitation to join our network, we have sent this because we have a legitimate interest in growing our network. You have the right to opt out from receiving any further requests to join the network and can do so at any time.

International Transfers

Where your data is transferred outside of the UK or the EU, we make sure that your data is given the same level of protection as the country you are located. This is either because that country has a comparable data protection standard (Adequacy), or by using another safeguard such as an enhanced contractual agreement (IDTA or SCC).

Your rights

Under data protection legislation, in certain circumstances you have the following rights over the processing of your personal data as described in this notice:

- right to be informed about how your data is used;
- right of access to your personal data;
- right to correction or rectification of your data;
- right to request deletion of your data; and
- the right to data portability.
