

### **Capt. Tony (TW) Williams**

Captain Tony Williams graduated Wayland Baptist University with a bachelor's degree. He served in the United States Marine Corps; serving during Operation Iraqi Freedom. He returned home and joined the Lubbock Police Department in 2003. During his 12 years with LPD; he spent six years on patrol and six years in the Narcotics unit. Tony was a Field Training Officer, Defensive Tactics Instructor, Taser Instructor and a member of the LPD SWAT team.

Capt. Williams has been with the Lubbock County Sheriff's Office for seven years as a Staff Sergeant with the Narcotics Unit; he was promoted to Captain in January 2024. Capt. Williams is also a Task Force Officer with the DEA and has been for six years; he is currently the Group Supervisor for the DEA & HIDTA. Capt. Williams is certified as a Narcotics expert in the Lubbock District Courts.

Capt. Williams has won numerous awards in his career. He received Officer of the Year from the Lubbock Sheriff's Office and Officer of the Year from the Texas Narcotics Association. He has received three Award of Excellence from the DEA and also from the United States Attorney's Office. Capt. Williams is highly respected in his field of expertise on the local, state and federal level.

### **SSgt. Cody Kidd**

Sergeant Cody Kidd joined the Lubbock Police Department in 2006. During his 10 years at LPD; he spent time in Patrol and 5 years in the Special Operations (Narcotics) unit. Sgt. Kidd holds TCOLE Instructor License/Certificate; he has instructed Patrol Procedures while at Lubbock Police Department.

Sgt. Kidd has been with the Lubbock County Sheriff's Office since 2017. He has spent his 6 ½ years with LSO in the Narcotics Unit.
