A motion was made by Slaymaker, seconded by Chvala to appoint Wendy Ayers as Board Secretary/Treasurer. Motion carried.

Secretary Ayers administered the Oath of Office to Board President Bobbi Miller, Board Vice President Ellen O'Rourke, and Board member Tiffany Kriegel.

The board discussed the SBRC application for open enrollment out not on prior year's headcount in the amount of \$127,175.23. A motion was made by Slaymaker, seconded by O'Rourke, to authorize district administration to submit a request to the School Budget Review committee for a modified supplemental amount of \$127,175.23 for open enrolled out students who were not included in the district's previous year certified enrollment count. Roll call vote. Slaymaker aye, Kriegel aye, O'Rourke aye, Miller aye, Chvala aye. 5-0 Motion carried.

The board discussed the Drop Out/At Risk plan and application/MSA for the 2026-2027 school year in the Amount of \$139,442. A motion was made by O'Rourke, seconded by Chvala to approve the At-Risk/Dropout Plan for the 2026-2027 school year. Roll call vote. Slaymaker aye, Kriegel aye, Miller aye, O'Rourke aye, Chvala aye. The motion passed by a vote of 5-0. Motion carried.
