


Figure 1. Architecture of a typical wireless sensor node.

References. We use the standard Chicago style in compiling the bibliography. Writing bibliography using alphabetical order and not using numbering. The same author (with different works) must be written with the full name, not using dashes. All references must be in the same format as the ones at the end of this document and the reference list must include all cited literature.
