VI. Real Estate Commission Policy

The EDA recognizes the region's Real Estate community plays an important role in facilitating commerce in Amherst County. Dalton attended a reception hosted by Sweet Briar College for Centers of Innovation in Technology. The Town and County hosted a Sweet Briar College presentation by President Woo on SBC updates.
