Citation (in this conversation) = Documented use of museum specimens in the literature

Various versions of GBIF data that can be cited

- Full dataset at time of access for research
- Dataset of specific occurrences included in research
- Dataset on IPT
- Individuals specimens

About 7 months for paper publication to when the citation shows up in GBIF dataset citations

Now that we are sharing data online people can publish on our specimens without ever processing a loan for our specimens, so how do you make sure you know that the specimens are being used in research, published on, and being cited properly?

What are the implications for how citations should be tracked in specimen records when they are included in a dataset that is cited in a paper (through something like GBIF)? Where is the balance in the detail we should be recording internally?
