6. You shall check and ensure that the materials / equipment delivered are correct, fully comply with the contract specification and/or consultant's requirements and are free of defects.
7. You shall indemnify us against all costs, claims, liabilities and damages resulting from your breach of this Agreement and/or any related legal actions arising there from, all costs incurred shall be deducted from any payment due to you or which may become due to you or as a debt recoverable from you.
