#### What is DELAC?

Parent advisory committee to provide guidance about English Learners

(California Education Code [EC] sections 52176[b][c], 62002.5; Title 5, California Code of Regulations [5 CCR] Section 11308)

### **DELAC Responsibilities**

The DELAC has the following responsibilities:

- 1. Advise the principal and school staff on the programs and services provided to English learners; development of a school master plan for education programs and services for English learners.
- 2. Establishment of district program, goals, and objectives for programs and services for English learners.
- 3. Advise the on the development of the LCAP.
- 4. Assist with developing and conducting the school's needs assessment.
- 5. Assist with the school's efforts to make parents aware of the importance of regular school attendance.
- 6. Review and comment on the written notifications required to be sent to parents and guardians.
- Development of a plan to ensure compliance with any applicable teacher and/or teacher aide requirements.
- 8. Review and comment on the school district reclassification procedures.
- The consolidated application must also include certifications by appropriate district advisory committees, including the DELAC, that the application was developed with review and advice of those committees. (EC Section 64000[c])

### Why is DELAC important?

- FAMILIES gain skills and confidence to help their children learn, navigate the the school system, generate ideas to improve learning opportunities, and drive positive policy changes.
- **STUDENTS** feel supported and reassured when the most important adults in their lives are working together to help them learn.
- **TEACHERS** gain insights into their students' strengths and challenges, allowing them to enrich instruction and integrate students' experience into classroom lessons. Collaborating with families also creates shared purpose.

## Why is DELAC important?

- SCHOOL: when schools become more welcoming and inclusive, it transforms school climate
  in ways that benefit everyone. By engaging families with a spirit of partnership, schools
  become rooted in and reflecting the lives and experiences of their students, families, and
  community.
- SCHOOL DISTRICT: Listening to students, families, and community members helps school districts improve their policies and practices.

### **DELAC** meetings

- A minimum of 4-5 meetings per school year is recommended.
  - Any meeting shall be open the public, meeting notice shall be posted at least 72 hours before the meeting, agenda must include public comment section
