If under 18 you must have parent permission [obtained during registration]

**Fields Required:** Name, Code from teacher. Do NOT create students accounts that may ask for SSN, address, or other personal information.

**Student Login Example:** Name: First Name

**Notes:** Teacher must create an account, class roster, and lessons in their account. Students access through the student site <https://classflow.com/student> with a code from the teacher.

This ClassFlow Privacy Policy (together with our ClassFlow Terms of Service and ClassFlow Acceptable Use Policy and any other documents referred to on it) explains how Promethean collects, holds, uses and discloses any personal or other information that we collect from you and from third parties or that you otherwise provide to us. Please read the following carefully to understand our policies and practices regarding your personal and non-personal information and how we will treat it. This policy does not apply to third party websites or applications to which we provide links from our Service.
