NBA Showcase Contest Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN.

The NBA Showcase Contest (the "Contest") starts on April 12, 2021 at 12 pm PDT and ends on May 12th, 2021 at 12 pm PDT (the "Contest Period").

ELIGIBILITY: The Contest is open to NBA Top Shot users (as defined as a user with an account at www.nbatopshot.com, and a valid email address associated with that account) who are of the age of majority in the jurisdiction of their residence. Employees of Dapper Labs Inc. ("Sponsor", "we", or "us"), the NBA Entities (defined as NBA Properties, Inc., the National Basketball Association (the "NBA"), NBA Media Ventures, LLC and the NBA member teams (collectively, the "NBA Entities"), and its and their respective parents, subsidiaries, affiliates, promotion and advertising agencies, and members of their immediate families (spouse and parent, children and siblings and their respective spouses, regardless of where they reside) and persons living in the same household, whether or not related, of such employees, are not eligible to win. Void where prohibited by law (specifically, in Canada, the Contest is not open to residents of Quebec). The Contest is subject to all applicable federal, provincial, state and local laws.

HOW TO ENTER:

There are fifty (50) Showcase Playoff Prizes, ten (10) Finals Prizes and three (3) Grand Prizes (collectively, the "Prizes") associated with the Contest. You can also receive a Participation Benefit (defined below) by participating. You can receive a Participation Benefit and/or enter the Contest as follows:

- 1. First, create a "Showcase" on your account with NBA Top Shot using at least three (3) Moments. If you receive twenty (20) or more "likes" on your Showcase, you will be entered into the Contest, and you will also receive a \$20 Dapper Balance credit drop (the "Participation Benefit"). Each user can only enter the Contest once, and can receive only one Participation Benefit.
- 2. Eligible participants can also receive a Participation Benefit without purchase by mailing an index card with their name, mailing address, and email address associated with a registered NBA Top Shot account (you understand and agree that by sending us this information, you authorize us to use it to determine whether you are an eligible participant) printed on one side of the card to Sponsor at Dapper Labs Inc., 600-565 Great Northern Way, Vancouver, BC V5T 0H8, Canada, Attn: NBA Showcase Contest, provided it is received by Sponsor before the end of the Contest Period. You acknowledge that since you are not creating a Showcase, you will not be entered into the Contest.
- 3. The fifty (50) users who have entered the Contest as provided in Section 1 above and who receive the most "likes" on their Showcases as of May 4th, 2021 at 12pm PDT will be submitted to the "Showcase Playoffs." Sponsor reserves the right not to award all prizes if, in its sole discretion, it does not receive a sufficient number of eligible and qualified entries. Winners of the Showcase Playoffs will win an Early Adopters pack (the "Showcase Playoff Prize"). Each user can win only one Showcase Playoff Prize. Showcase Playoff Prize awards are subject to verification of eligibility and compliance with these Official Rules.
- 4. The ten (10) users who have entered the Contest as provided in Section 1 above and who receive the most "likes" on their Showcases as of May 4th, 2021 at 12pm PDT will be submitted to the "Showcase Finals." Sponsor reserves the right not to award all prizes if, in its sole discretion, it does not receive a sufficient number of eligible and qualified entries. Winners of the Showcase Playoffs will win a Rising Stars pack (the "Showcase Finals Prize"). Each user can win only one Showcase Playoff Prize. Showcase Finals Prize awards are subject to verification of eligibility and compliance with these Official Rules.
- 5. A team of judges established by Sponsor (which will be members of Sponsor's development team) will judge the entrants in the Showcase Finals to determine their favorite three (3) entries as the winners. Winners will be determined by which entries the judges feel most deserve to win, based on the theme of the Contest and the nature of the submission. Judging will therefore be subjective. Sponsor reserves the right not to award all prizes if, in its sole discretion, it does not receive a sufficient number of eligible and qualified entries. Winners of the Showcase Grand Prizes will win a Holo Icon pack

(the "Showcase Grand Prizes"). Each user can win only one Showcase Playoff Prize. Showcase Playoff Prize awards are subject to verification of eligibility and compliance with these Official Rules.

Winners of all Prizes will be announced via Twitter. We will send an email notification to the winner of each Prize at the email address associated with their winning account within 24 hours of our decision. The winner will receive their Prize, which will be transferred to the account associated with the winner, within 24 hours of the time we notify the winner, provided that the winner (i) provides us with his or her NBA Top Shot profile account information or public digital wallet address within 24 hours of receiving notice of their status as a winner, and (ii) if applicable, correctly answers the skill-testing question set forth below (the "Skill Test"). If we are unable to contact a winner within a reasonable time period or a winner fails to provide us with the information stated above within the timeframe stated above, they will immediately lose their status as a winner, and we may, at our sole discretion: (i) in the case of Showcase Playoff Prizes, award the Showcase Playoff Prize to another winner selected by the Sponsor's judges; (ii) in the case of Finals Prizes, award the Finals Prize to the user with the next most votes in the final poll; (iii) in the case of Grand Prizes, award the Grand Prize to the user with the next most favorable Showcase as deemed by our team of judges. This process will continue until all Prize(s) are distributed.

If a winner is a resident of Canada (other than Quebec), in order to qualify as a winner of a Prize, the winner must first correctly answer the following Skill Test:
