

Privacy Policy

1. Introduction Welcome to Glare, a photo editing application developed by FamexApps ("we," "our," "us"). We are committed to protecting your privacy. This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you use our application, Glare. Please read this Privacy Policy carefully. If you do not agree with the terms of this Privacy Policy, please do not access the application.

2. Information We Collect We may collect information about you in various ways. The information we may collect via the application includes:

2.1 Personal Data

Personally identifiable information, such as your name, email address, and other contact information that you voluntarily give to us when you register with the application or when you choose to participate in various activities related to the application.

2.2 Derivative Data

Information our servers automatically collect when you access the application, such as your IP address, your browser type, your operating system, your access times, and the pages you have viewed directly before and after accessing the application.

2.3 Mobile Device Data

Device information, such as your mobile device ID, model, and manufacturer, and information about the location of your device, if you access the application from a mobile device.

2.4 Face Data

When you use our photo editing features, we collect and process images of your face to apply physical changes such as makeup, slimming, face modification, and other enhancements. However, we do not store your facial data and we do not share it with third parties.

2.5 Third-Party Data

Information from third parties, such as personal information or network friends, if you connect your account to the third party and grant the application permission to access this information.

3. Use of Your Information Having accurate information about you permits us to provide you with a smooth, efficient, and customized experience. Specifically, we may use information collected about you via the application to:

- Create and manage your account.
- Process your transactions and send you related information, including purchase confirmations and invoices.
- Improve the app functionality, including enhancing photo editing features.
- Communicate with you about products, services, offers, promotions, rewards, and events, and provide other news and information about FamexApps.

- Monitor and analyze usage and trends to improve your experience with the application.
- Detect, prevent, and address technical issues.
- Perform other business activities as needed.

4. Disclosure of Your Information We may share information we have collected about you in certain situations. Your information may be disclosed as follows:

4.1 By Law or to Protect Rights

If we believe the release of information about you is necessary to respond to legal process, to investigate or remedy potential violations of our policies, or to protect the rights, property, and safety of others, we may share your information as permitted or required by any applicable law, rule, or regulation.

4.2 Third-Party Service Providers

We may share your information with third parties that perform services for us or on our behalf, including payment processing, data analysis, email delivery, hosting services, customer service, and marketing assistance.

4.3 Affiliates

We may share your information with our affiliates, in which case we will require those affiliates to honor this Privacy Policy.

4.4 Business Transfers

We may share or transfer your information in connection with, or during negotiations of, any merger, sale of company assets, financing, or acquisition of all or a portion of our business to another company.

5. Security of Your Information We use administrative, technical, and physical security measures to help protect your personal information. While we have taken reasonable steps to secure the personal information you provide to us, please be aware that despite our efforts, no security measures are perfect or impenetrable, and no method of data transmission can be guaranteed against any interception or other type of misuse.

6. Policy for Children We do not knowingly solicit information from or market to children under the age of 13. If we learn that we have collected personal information from a child under age 13 without verification of parental consent, we will delete that information as quickly as possible.
