Summary of Articles:

The purpose of these articles is to impeach Prime Minister Pope Francis from the Prime Minister position.

Section 1. Grounds/Reasons

I. Incompetence

A. Prime Minister (also referred to as PM) Pope Francis has shown an unacceptable level of incompetence throughout his time as PM.

1. This includes:

- a) Failing to realize that MOJ (Minister Of Journalism) SillyPossibility had punished a News Company for inappropriate news articles (they were banned) and harassed him [MOJ SillyPossibility] to punish them [the News Company] even though MOJ SillyPossibility had revoked their press pass and deleted the article.

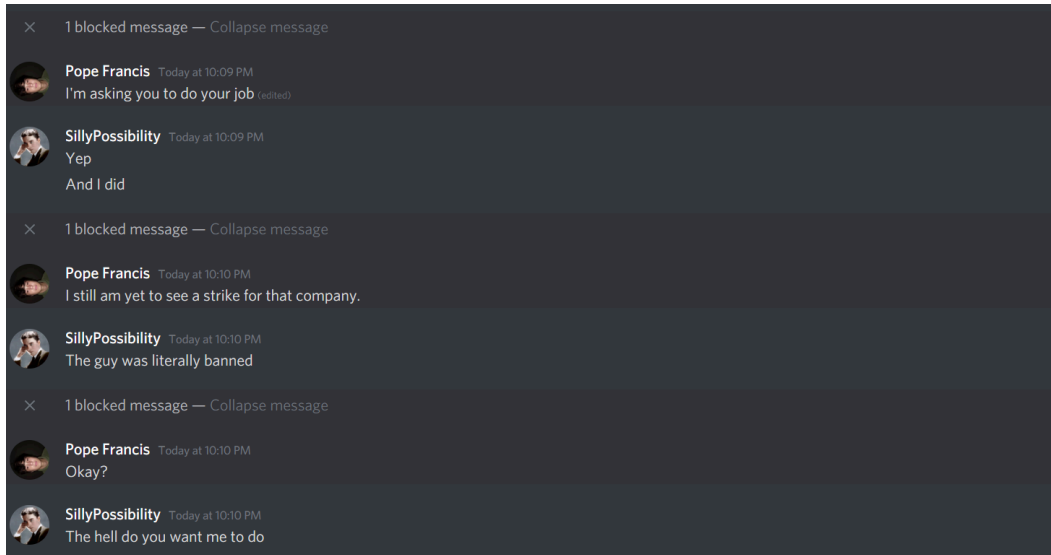
III. Extreme Dishonor to the Office

This case began from my Duties as a Court Justice. I started it as it is my duty to uphold and maintain the law. The Law was broken and pursuant to my duties, i must bring action against lawbreakers, in order to pursue Justice. Now that I have stated my reasoning as to file this suit, We may begin.

For some Context, The Defendant With us today is the Prime Minister of Vooperia, i will henceforth call the Prime Minister, "PM". During the Voting Session of the Week of November 15th - November 21st, A bill was up to vote, establishing a Term Length for the Prime Minister-ship, this length would be 4 months. This was in fact not a Term Limit, only a length of which a PM can serve before an election can commence. This bill was officially Passed on Sunday, November 22nd, 9:57 PM CST. It was then illegally Vetoes by the PM, as Shown in the Surge V. Pope of November 25th Case that concluded earlier today, on November 24th 9:54 PM.

A Snap Vote was then Started on November 24th, 10:15 PM. The Snap Vote was preceded by the Revocation of the Veto by the PM. The Vote itself was over a Compromise proposed by the emperor, To start the 4 Month Term on that date of November 24th, rather than the Defendant's Inauguration, and Start of the Term. This Violated Several Portions of the Snap Vote Definition Act, which i will henceforth refer to as the "SVDA"

The Defendant Tried to get me to drop the case, stating "He was given the emperor's Permission". However The Permission of the Emperor doesn't negate the Law, as seen in the Case Tyco V. Luka. This shows a worrying disregard by the Prime Minister about the Law, and his opinions on being allowed to flout the law due to the Emperor's support. (edited)

This Blatant Disregard is dangerous to our Democracy, as the Rule of Law is a cornerstone of that. The Rule of Law says that No man is above the Law, All men serve it, and must abide by it. The Fact that the Second most powerful Person in our Nation, The Prime Minister, can disregard that is a Dangerous Sign. And one that he has shown before.

And so to finish this statement, I shall point back to the SVDA, which prescribes a punishment for violations of the Act,
If a Prime Minister violates any portion of this act, any item presented in the Snap Vote shall be struck, and they may be subject to impeachment from their positions.
Now, to address that last section of the Punishment prescribed by the SVDA, as it will have attention brought to it and will amount to some controversy. Impeachment would be heavy handed, and the Supreme Court on its own cannot Impeach, Articles of Impeachment are required. And if a Senator sees that the PM's actions rise to the bar of impeachment or a simple Vote of No Confidence, which is a less controversial though still controversial action, in their honest opinion, they can follow the Procedure prescribed for both avenues of removal. As this will show to the Vooperian citizenry that Checks and balances, another cornerstone of a functioning Democracy is alive and well in Vooperia.

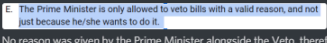

Now to the subject at hand, Earlier this week, I proposed a bill that would outline the voting periods and method of voting for Prime Minister. I finalized the bill with help from Senator Allegate and Senator Surge. As with most bills, I posted the edit link to it in [#senate-private](#), as is the norm. Not once through the creation of this bill did I ask or direct the defendant to make any changes to this bill. I proposed the bill and went on my way. What we would later find out is that the defendant, without confronting me first, 2 minutes before the senate vote, changed the bill and removed one of the largest parts of the bill. The bill I created, worked on, and proposed, was NOT the same bill that was up for vote. The defendant had claimed that it was his intention to decide the voting system separately as a vote in the Senate, however he unilaterally declared that the voting system was to be first past the post, without a vote, and in that case the defendant should have confronted the prosecution during the creation of the bill.

In an argument resulting from the actions of the defendant in the channel [#senate-private](#), Senator Danish announced that he would be running for the position of Prime Minister on a simple basis of "[he] want[s] ranked choice." Seeing this, the defendant reacted by attempting to block Senator Danish from running, an act that is not permitted through Vooperian law as his reasoning to run for the position does not change the requirements for office. The defendant attempted to justify this claiming that they had only "threatened" to do so.

During another separate occurrence, during the New Vooperian senate elections, the defendant attempted to call the election prior to the twenty-four hour mark. Following compliance with the aforementioned designated mark, a matter of constitutional ambiguity arose when a citizen rescinded their vote. This put the vote to a tie, which under Vooperian law, is sent to the Emperor to break the tie. However, the defendant took it upon himself to break the tie with power he did not possess. Following this decision, the defendant proclaimed a clarification in the rule of law prior to any pre-existing legal basis to do so, under the pretext that he was the election official. In doing so, the defendant circumvented the legal responsibilities of the Supreme Court, going as far as to say he "interprets the law."

Is a statement that is trying to accuse the Supreme Court of tyranny if they rule against Jam. This statement is not just disgusting - it's the exact opposite of how our justice system should work. We do not threaten the courts with slander when we do not get our way, Mr. Jam.
First, I will hit section two of this argument - that Danish was blocked from running without any reason.

Danish literally, themselves and recently, admitted they do not fit the standards for the position. They are actually currently appealing to be able to break the standards! So claiming Pope's blocking of his run was simply based on ranked choice voting shows you never even looked yourself to see if Danish fit the requirements - you probably should check this before making baseless accusations. Danish is *not* eligible to run, and while Pope's stated reason was not legally based, there is clear legal backing to the decision.

Now let me touch upon your first point,

Pope did, in fact, change the bill **before** voting began and we should probably write a bill outlawing this. However, as it currently stands, the only illegal action is modifying a bill **after** voting has begun. Quite simply put, it's somewhat surprising that our Senate does not check bills that are posted in [#senate-voting](#), to ensure that nothing has been changed last second. Scummy? Yes. But impeachment needs to be based on law, or we can probably kick out all of our Senators for similar behavior - even I have changed a bill near to its vote, in the case of the Education modification bill. Just because nobody read it, does not mean it's my fault. Anyways, this case diverts in the fact that the bill was not primarily Pope's to edit - which, again, we should write a bill about. We are Senators, and making law trumps impeachment trials with no legal backing. Again, case law does not work when it comes to the government - or we can impeach for anything at all, and declare it a law afterwards!

In the third case, Pope was actually justified in calling the vote as all voters had voted. In the normal voting system, which was the standard before we removed honk, we decided if all voters had voted, or a supermajority was held, the vote could be ended early for simplicity. In the end, the tie that was created (although should not have been) was handed to me to deal with, as it legally should have. To begin this rebuttal, it must be pointed out that the defense's opening statement was itself a rebuttal. Opening Statements are meant to be non-argumentational in theory, while in practice there can be some augmentative language in an opening statement. What is allowed is nothing to the degree of the Defense's "opening statement", which failed to be an opening statement and was nothing more than a rebuttal of our opening statement. That being said, we will move on as normal.

First off, the prosecution now recognizes that Senator Danish was lacking the prerequisites for running for Prime Minister, however this does not refute the fact that the defendant had denied him the ability to run purely based on his reasoning rather than him not fitting the requirements. Furthermore, Senator Danish had only realized that he did not fit the requirements *after* his bid for the position of Prime Minister had already been put forth. The defendant was still attempting to block a member of the legislature from becoming the Prime Minister who, to anyone's knowledge at that point in time, was otherwise fit. If the defendant were to have pointed out Senator Danish's inability to run based on his missing the requirements, this case would not exist in the first place. The defendant at the time argued that they only threatened to stop Senator Danish from running, but this is false. The defendant fraudulently used his power as interim manager of the senate to temporarily block Senator Danish from the official Prime Minister Candidate List. In summary, when the defendant illegally and fraudulently tried to block Senator Danish from running for Prime Minister, he did so with the knowledge that Senator Danish was able to run.

The Prime Minister Voting Act was, in fact, edited before the vote had commenced (See Exhibit A), however it was edited by an outside party without the author's permission and without said author even being informed of the edit being made. Due to the timing of the bill's creation, many senators were only able to see the official completed version of the bill, and only a few senators would read the incorrect version of the bill, and they would not know this was in fact, the incorrect version. The Defendant has claimed that it was his intent to provide a vote on whether we should use instant runoff or first past the post. (See Exhibit B - Timestamp 3:00) However, he didn't organize a vote, didn't inform the author of the bill beforehand, or even propose this vote during the voting session, instead the defendant unilaterally declared that it would be first past the post. The defense has recognized that this act should be recognized as a crime, but that the person who has committed said crime should not be charged. Was the first person to defraud a bank not charged with a crime? Was the first person to kill another not met with reprimand? Why would someone who causes the creation of a law due to how horrible an act they committed receive no repercussions? And if we wish for the defendant to learn from his mistakes, we should negatively reinforce the idea that this was a heinous act. The prosecution is not using these actions against the defendant because of their direct breaking of laws that do not currently exist. However, taking from the United States' impeachment law as an example due to our lack of laws on the subject, impeachments don't have to be from criminal acts. (See Exhibit D and E) While what has been cited is not directly Vooperian Law, we can advise ourselves with it as can the Court.

The Supreme Court can only impeach on grounds of corruption, espionage, voter fraud (only applies to official polls), inactivity (one or more weeks without notice), and any other reason that the Emperor approves. Corruption is defined by Oxford Languages as dishonest or fraudulent conduct by those in power, typically involving bribery. It is also defined by meriam webster as dishonest or illegal behavior especially by powerful people (such as government officials or police officers). The defendant, as the De Facto Interim Prime Minister, can be considered a powerful person, and while in this case it doesn't involve bribery even the defense recognizes that his act on the bill was scummy and/or dishonest. It could even be considered fraudulent. Eitherway, the defendant's action meets the definition of Corruption.

One could even argue that the defendant's actions were espionage, as they changed many items of the bill without notice and without informing the author. One could even go as far as to compare this to a spy breaking in and changing important legal and political documents of an adversary.

In the case of the New Vooperis election, voter turnout had reached only a fraction of the full population of the district (Exhibit F). By the point which the defendant wished to end the elections, not all citizens had voted, and the decision to end the voting period could potentially prevent citizens from exercising their constitutional right to voice their choice through voting. Beyond the attempt to end the vote before the allotted time, the defendant's blatant disregard for the need to delegate matters of constitutional ambiguity to the Supreme Court sets a dangerous precedent for the way in which the separation of powers functions within our government. The defendant went as far as to claim he himself was able to interpret the law (Exhibit G, Exhibit H)

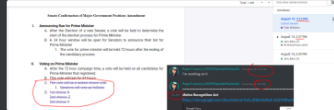
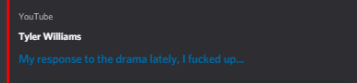

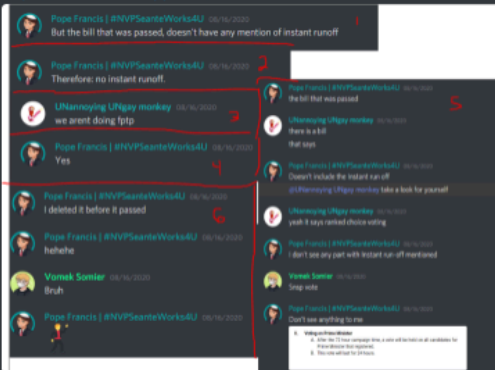

Impeachment Grounds

Is Impeachment Limited to Criminal Acts?

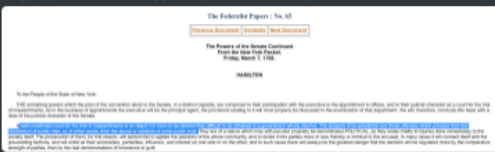
The Constitution describes the grounds of impeachment as "treason, bribery, or other high Crimes and Misdemeanors."⁴² While treason⁴³ and bribery⁴⁴ are relatively well-defined terms, the meaning of "high Crimes and Misdemeanors" is not defined in the Constitution or in statute and remains somewhat opaque. It was adopted from the English practice of parliamentary impeachments, which appears to have been directed against individuals accused of crimes against the state and encompassed offenses beyond traditional criminal law.⁴⁵

Some have argued that only criminal acts are impeachable offenses under the United States Constitution; impeachment is therefore inappropriate for non-criminal activity.⁴⁶ In support of this assertion, one might note that the debate on impeachable offenses during the Constitutional Convention in 1787 indicates that criminal conduct was encompassed in the "high crimes and misdemeanors" standard.⁴⁷

The notion that only criminal conduct can constitute sufficient grounds for impeachment does not, however, comport with historical practice.⁴⁸ Alexander Hamilton, in justifying placement of the power to try impeachments in the Senate, described impeachable offenses as arising from "the misconduct of public men, or in other words from the abuse or violation of some public trust."⁴⁹

It's extremely easy to write paragraphs trying to explain why people *should be charged* with crimes. I won't waste your time. Mr. Pope did not, in any way, break a current standing law. Pope had a lapse of judgement, but that is not criminal. Even in cases of legitimate bribery and manipulation, this court and senate has decided with individuals for the sole reason of their actions not being illegal.

We are running a legal system, not a moral judgement system. In order to be impeached, an official must perform an impeachable offense.

I would ask the judge to strike the second charge concerning Danish entirely - the situation resulted in no damages to Danish himself, as he was not eligible to vote in the end. If Pope had infringed on their right to run, it would be one thing, but in the end, no law was broken. This is also ignoring Pope has zero power over that - being allowed to run is a SC and Emperor issue. I can say "I will stop Joe Biden from running for office!" right now, but that is not a crime in itself. Saying something that you have no power to actually do is not illegal - and even if you had the power, speech is not enough to prosecute. You remember how my opening statement contained a swear? The judge may not have liked that, but I cannot be prosecuted for it. This is the same principal - we do not charge based on speech.

I don't think Exhibit H adds much to your case. Pope knew he did not break the law - and he consulted me as he should have. That entire situation was handled through me, so if you have an issue with how that vote was handled, start a new case against me, not Pope. I instructed him that the vote should not have been changed last second - and even that if it was, I would be siding with whomever had the majority prior. He followed my decree.

I'm going to also say the Federalist Papers and American documents are not Vooperian, and hold literally no sway in our law. Want me to grab something from North Korea saying dictatorship is OK? How does this influence our legal system in any way? Can I pick and choose governments to pull legislation from? Do we not have our own government for the sole purpose of separating ourselves from other nations?

There was no bribery here - some bad judgement, yes. And Pope has shown his ability to apologize and work on his mistakes, as we all should. I would agree with a punishment for Pope - possibly a fine, or a censure. However, these current charges are not grounds for impeachment. The second wave of elections are in full swing - allow Pope's voters to decide his fate, not a gavel backed by partisans trying to find any reason to remove him before the PM elections.

These charges are political, charged, and flimsy. Danish himself only ran for PM to force a change in the voting system - is that not manipulation and corruption in itself? Why are we so focused on Pope when others show a clear intent to sway our systems in order to score political points?

May I also add:

In summary, when the defendant illegally and fraudulently tried to block Senator Danish from running for Prime Minister, he did so with the knowledge that Senator Danish was able to run. Is a complete lie - Pope did nothing to block Danish apart from saying his disapproval, and even referred to consulting me on the matter - which was the correct action to take. Furthermore, Pope clearly did know Danish was not able to run, as he said he wasn't. The prosecutors cannot read minds, and just because Pope did not mention other reasons does not mean he was unaware of them. We cannot prosecute based on what we *believe* people had in their mind.

Danish played a dirty game to force a political change and it backfired, and now he's crying wolf.

Etho lost his election and is complaining over a 20 minute period when even after one of the votes changed (which is generally not allowed), he was still in a tie.

Danish and Etho were both looking to become PM.

This is quite literally PM candidates finding reasons to try to disqualify Pope, using the courts as a way to bypass the democratic elections that put him here.

The Defense has stated "[The defendant] had a lapse of judgement, but that is not criminal". To start this argument on a lighter note, this is the same defense used by Richard Nixon when discussing the Watergate scandal. Amusing historical tidbits aside, this statement is false, at least according to previous case law established under the case of VNB v. LIL; "[The defendant's] actions, even if not currently criminal, should be made criminal... We need to decrease corporate risk, and treating this like it is will set that as precedent: A crime." The statements of that prosecution and the resulting decision show how the court has previously made criminal decisions based on the actions of an individual even without pre-existing laws determining that those actions were criminal. The prosecution's request, being the same as it was when the original appeal was written, is that the court both create case law through repercussions up to and including impeachment; and recommend to the senate the creation of a bill to prevent this in the future.

As the prosecution had acknowledged in the first rebuttal, the examples of the United States Constitution and the Federalist Papers were obviously not meant to represent the current laws of Vooperia. They were brought forth as an example of a real world system of impeachment. We readily agree that these do not directly dictate our every move in Vooperian courts, we simply realize a functioning political system and attempt to show how that applies to our current situation. Again, to quote the case of VNB v. LIL, "what [the defendant] did would be considered illegal in every single country in the world". Examples can be taken from other countries to influence our decisions, and when there is no codified law which explains it well, it is a good place to fall back on. To answer the questions from the defense; papers from a wholly different political system from the one we currently operate under most likely won't apply to any conversation; other government's systems do not influence our legal system, but it can inform it; the legislation of other governments can be used as an example; our government exists not to separate ourselves from others but to unite ourselves as one, and cooperation with other is the signal of a thriving world.

(See Exhibit I) This would be more akin to "I'm going to stop Donald Trump from running by refusing to put him on the ballot" (see Exhibit I and J, specifically the Timestamp on the defendant's statement in exhibit I) During the Two minutes upon which he chose not to put Danish on the list, he was blocking Danish's ability to run from Prime minister, by not putting him on the list that would eventually be on the Ballot. An Act that the Defense states he has no power to do, yet he had done it. It only comes out that he wasn't eligible to run 2 days later. So to the knowledge of the defendant at the time, he would be committing an unlawful act, as he had no power to block Danish on the grounds which he did.

Regardless of the potential outcomes of the New Vooperis election, Vooperian citizens have the right to exercise their right to vote over the allotted period of time. For this reason exactly, Mr. Ethosein pushed to have this recognized by the defendant (Exhibit F). The more concerning action by the defendant in this instance is their insistence that they possess the power to interpret the law, a power that is delegated *by law* to the Supreme Court (Exhibit H). This claim presents itself as a concerning display of the defendant's unwillingness to abide by the rule of law, and creates a dangerous precedent for what could be perpetrated by the defendant in the future.

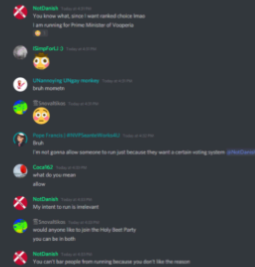
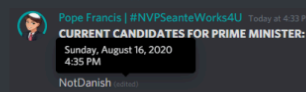

Just because you want it to fit under that definition does not make it a crime. Pope did not lie about his actions, and he was open after being questioned. Pope was not dishonest, nor did he engage in what is typically defined as fraudulent activities. Again - Pope did something scummy. Possibly a fine or censure is in order - not impeachment.

You use the case with LJ as some sort of attack, when in reality it backs my defense. First off, case law does not work when it comes to impeachment - for reasons I have already stated. But more importantly, was LJ impeached from his government positions after that case? Not LJ being impeached was never even set on the table, as he did not commit a crime that was currently defined. Pope should, similarly, be prosecuted normally with a fine and whatever other charge is reasonable, not impeached. You also forget that the LJ case should never have been a SC case in the first place, and we all agreed that civil cases would never touch the SC again. This really is a poor comparison to make.

You can make many comparisons to the LJ case, but the important thing is that he was never reprimanded within the government system - only personally and monetarily. Morality should be decided by the voters, and legality should be left to the law when it comes to our government officials.

Pope never had any power to block Danish in an official election, and was not in charge of the election. It does not matter if Danish was not included on his list - his list was not official. Once again, disagreement, and even *being wrong* is not illegal. If Pope had incorrectly blocked Danish from running, the SC would have overturned it as it should. However, Danish could not fit the requirements in the end, so no damage was done.

Exhibit J is even showing Pope following the SC's orders as he should. An impeachable offense would be refusing the SC's decision - not willfully following it.

In Exhibit H, Coca is completely correct in being confused - Pope had no power to block Danish, and should have been questioned. But again, being wrong is not illegal.

The defendant's action of editing the Prime Minister Voting Act, in any circumstance, should be considered as an act of deception and corruption. They had changed a bill without authorization from even the author two minutes before the start of the vote in the Senate. Afterwards they had announced that the exact opposite of what had previously been within the bill. Eventually, the defendant had claimed that the intention was to call a vote for the electoral process, after the scandal broke, but no vote was called until a full two days of controversy had passed even though the defendant had the full capability to put it up to a vote during the time the bill was being voted on. The defendant's actions clearly show how they had lied by the direct action of omission and made false claims that were only substantiated after extreme controversy had forced their hand. The prosecution recommends reprimand through no longer allowing the defendant to be in charge of putting forth votes in the Senate and requesting a formal Senate inquiry into these specific actions of the defendant.

The defendant had clearly stated that "[he's] not gonna allow someone to run just because they want a certain voting system". The prosecution wholly agrees with the defense that this reasoning can be considered questionable, however the reasoning behind a person running has no effect on their ability to run, morals do not change the law. The defendant also made no mention of the actual reason Danish would not at that moment be able to put in their bid for the position of Prime Minister, and their response to questioning about the decision goes "with Spike's support, I might as well have [the authority to do] it". The defendant was clearly attempting to block Senator Danish from putting their bid in on the basis of not liking their reasoning, which is an illegitimate ground to bar someone from running. It is recognized that no actual damage was done through these actions, but the fact that they were committed merits consequences. The prosecution suggests a fine of up to \$10000 to be decided by the court for Senatorial misconduct by the defendant.

In their actions during and after the New Vooperis elections, the defendant showed themselves to display disregard for the systems in place within the legal code of Vooperia for both electoral proceedings and interpreting ambiguity in the rule of law. The simple fact that they stated "I interpret the law" clearly displays this disregard, and sets a dangerous precedent for the possible future actions of the defendant if kept in power. The prosecution puts forth that the defendant should no longer be allowed to manage elections and that the defendant no longer be allowed to give themselves access to channels that they are not permitted to be in.

As Pope's defense, I will try to make this quite simple - the defendant has, in the past, dealt with a slew of frivolous suits and been treated poorly on this server by users who continually pester and even bully him in an attempt to lower the status of him and his party. In acts of stress-induced impulsivity, Pope did in fact make stupid decisions.

The defense holds to that the Danish situation was not in any way illegal, and the prosecution has admitted there were no damages. Even if you did not see that legal disclaimer, on the last question on the General Elections of Vooperia City's ballot it states "Anyone submitting this ballot is subject to Election Act §5.A.I.a and Election Act §4.II.A" and also "By clicking "SUBMIT" you agree that you are in the district of Vooperia City, and are following proper election laws." As shown in Evidence 4, again means you are subject to the laws if you submit the ballot.

Vooperia City's General Elections has started! Make sure to go vote now!

Meaning he broke the Election Act law and is under authority of Vooperia City District which allows the district to prosecute him for breaking the law.

Now lastly, what I want to say is, Pope Francis has been my long time friend in this community, and I do not want this case to be taken negatively or too seriously on him or anything, what I want is to set a precedent within a Federal Government that if you acknowledge to be subject to another district's law(s) in exchange of an actual and legitimate service, goods, or products you are under the authority of that district's law, and gives the right to district to prosecute you for breaking their law(s). Finally, I want you to see the both definition of "subject" and "acknowledge" so you do not overlook what the meaning/definition is.

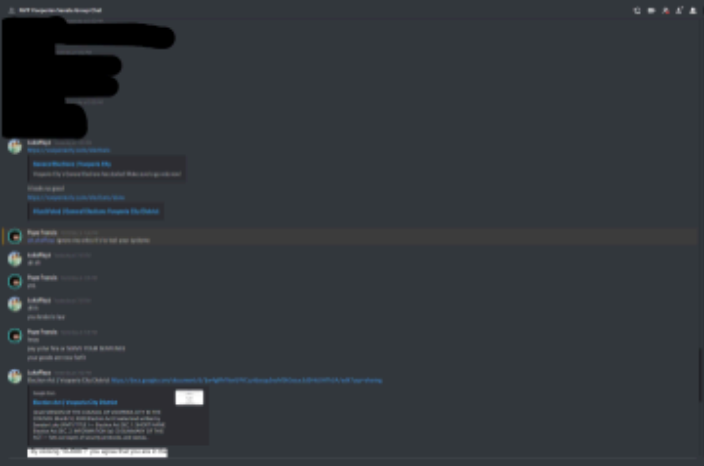
