- Some things are really difficult to find, such as getting started with ODDs
- What do we need to keep for historical reasons? What can we discard?
- What can we transfer to the WP?
- What about FAQ in the Wiki? It is kept up to date (https://wiki.tei-c.org/index.php?title=TEI-Council-FAQ)
- Google Drive for Council minutes.
- What is Council-related, Board-related, and borderline? E.g., educational materials.
- Perhaps a preliminary question needs to be if we should continue using WordPress. If yes, we need to do some plug-in updates. E.g., PHP upgrades.
- WP is currently a mix of HTML and TEI (and of the latter some work and some don't).
- Will TEI Publisher version replace the Guidelines as they are now? If yes, we will have to run eXist, which means adding a big chunk of infrastructure.
- Documentation repo is a good thing. We all agree on that. If we put something in the documentation repo...
- Objective: Have documentation in one place. Housed in one place *and* rendered the same way in one place.
- Three decisions:
 - Where to store it? in a repository so that we have version history (esp. working papers)
 - o How to process it?
 - O Where to publish it?
- Need a decision on the Wiki.
- Not everything in the documentation repo has to be TEI. We could do it in markdown and render it exactly the same way, if we get the stylesheet right. We could do the meeting minutes in markdown.
- If we are going to use the documentation repo, HC will get it into shape so that we can use it. → ACTION on HC
- MS will have a look at the Wiki. Consult with Syd, James, and/or Piotr who have project memory. → ACTION on MS
- 1. Inventory of where things TEI-Council-related are currently stored (started above).
- 2. Decide where things *should* be stored [with advice from Council]
- 3. Decide how things should be processed.

- 4. Move things into the right place.
- 5. Write up a Records Management document (a meta-TCW)
