PROXY INSTRUCTIONS

1. **Please fill out the proxy even if you plan to attend the Annual Meeting** so that we can be assured of a quorum. If you attend the meeting, your votes at the meeting will count and your proxy votes will be automatically omitted from the tally.
2. According to our Bylaws, the proxy must be ***signed by all owners*** of record.
3. Please **print** your name(s) and address at the top.
4. Indicate how you want your proxy to be processed. You can
 - indicate that you want to cast your vote for the election of Board members as indicated on your proxy, or
 - let Andrew Nagley (your designated proxy) cast votes on your behalf as he sees fit, or
 - cast no vote but be considered “present” for purposes of a quorum.If you leave all three options blank, then your proxy will be considered only for the purpose of determining a quorum, and no vote will be cast on your behalf.
5. If you select that you want to specify how your vote should be counted, you must also check the appropriate lines and/or write in the name(s) of the candidates for the Lakeport Board for whom you wish to vote (vote for no more than three).
6. ***Sign and date*** the proxy form in the space(s) indicated.
7. ***Submit your proxy in one of the following two ways:***
