### Personal information we collect

The personal information that we collect about you through the App depends on how you interact with us:

- Information that you provide voluntarily

The App may also collect information about how your device has interacted with the App, including the pages accessed and links clicked. - Others who otherwise process personal information for purposes that are described in this Privacy Policy.
