

State of San Andreas Mutual Aid Policy for Bomb Threat Response Version: 1.0.0











<u>Purpose:</u> The purpose of this Mutual Aid Policy is to highlight when and where Bomb Response Units respond in the case of a Bomb Threat to the citizens and property of The State of San Andreas.

This Policy consists of the following agencies: San Andreas Fire Marshals Hazardous Device Unit, San Andreas State Bureau Of Investigation EOD, Blaine County Street Safe Bureau Bomb Squad, Los Santos Special Weapons & Tactics Bomb Squad.

Activation Policy:

In the case of a Bomb Threat, a supervisor of any one of the respective divisions or departments are to ping in #SW-Tac-Ops a Bomb Squad Activation for the correct units for jurisdiction. The Jurisdiction will remain the same as High Risk Unit activations.

Jurisdictions:

In Any Jurisdiction if the Bomb is identified to be a hazardous bomb "Dirty Bomb" SAFR Hazardous Device Unit will be primary and a Team Lead will be assigned from the SAFR Hazardous Device Unit. The department for the respective jurisdiction will still respond.

In the case of a Bomb Threat in the City of Los Santos Jurisdiction, LSPD SWAT Bomb Squad & SAFR Hazardous Device Unit will respond. It is up to the Incident Commander of the scene to decide who will be Team Lead in Neutralization Efforts. It is up to the EOD Team Lead or Bomb Squad Team Lead to request further Bomb Squads to respond.

In the case of a Bomb Threat in the Blaine County Jurisdiction, BCSO SSB Bomb Squad & SAFR Hazardous Device Unit will respond. It is up to the Incident Commander of the scene to decide who will be Team Lead in Neutralization Efforts. It is up to the EOD Team Lead or Bomb Squad Team Lead to request further Bomb Squads to respond.

In the case of a Bomb Threat in the Northern Blaine County Jurisdiction (Paleto Bay), SAHP SBI Bomb Squad & SAFR Hazardous Device Unit will respond. It is up to the Incident Commander of the scene to decide who will be Team Lead in Neutralization Efforts. It is up to the EOD Team Lead or Bomb Squad Team Lead to request further Bomb Squads to respond.
