


Introduction: Preface

Greetings everyone, this is TheLegend87. Before I officially begin with the actual evidence regarding the subject of this document (ToyChicaEntertainment), I would like to take the time to give you some context on who exactly

ToyChicaEntertainment (whose name I'll shorten as "TCE" going forward) is, and how this entire situation started. TCE is the creator of the popular upcoming FNAF World fangame "FNAF World Update 3 (Reimagined)", and has currently amassed a large following of over 3,630 followers (as of this document's creation).



Many months ago (I can't recall the exact timeframe), I had befriended him on Game Jolt simply as a polite courtesy, but I didn't view or see him as anything more than a casual associate. Still, I had no reason not to trust him at that point. Around May 3rd of this year, he had posted a render as a gift for me (said post has been edited to remove the mention of my name, the reason for which will be told later).



Deeply appreciating the render, I had given TCE my thanks. Around a month later, he then messaged me, asking if I could possibly participate in a collaborative drawing with him. I was excited, so I agreed. A few days later (on June 14th), the collab drawing was finished, and it looked like what you see below.





After it was posted to Game Jolt, I shared it with some friends on Discord, and this was when I was officially informed about TCE's crimes. Just to clarify a few things in the following screenshots:

1. I have censored the identities of said friends in these screenshots to maintain their right to privacy, as well as keeping them anonymous in general so that they don't get harassed/caught in the crossfire from this situation. Do not, under ANY circumstance, ask me about their identities or anything else regarding them. This is just between me

- and TCE. Nobody else should get involved in this, and I'd like to keep it that way for the safety of my friends, who I hold dear to my heart.
- 2. In the first screenshot, when it mentions that the "original message was deleted", this is referring to the collab drawing you see above. After finding out the information that I did, I felt overwhelmed with guilt and decided to completely delete the collab drawing from my entire hard drive/social media accounts. The collab drawing is lost media, and I do not want anyone attempting to "find it". As you'll read later, it was deleted for a reason, and going forward, I don't ever want to be reminded of its existence ever again. If you had seen the drawing before it was deleted on Game Jolt, then please, I just ask that you forget its existence as much as I've tried to.
- 3. Each screenshot is numbered on the top-left, to show a rough history of events in the exact sequence they occurred.








After being told all of this information and being sent the evidence needed, I confronted TCE directly in DM's, albeit delicately to make sure I wouldn't end up being brash and rushing things. Upon telling him that I needed an explanation for something, he almost immediately said the following (all quotes will be verbatim): "Oh dear. I think I know what you want me to explain on something". Upon further inquiry, he then said this: "If you're referring to the screenshot of me saying that I dated a 14-year-old and saying the N-word, then that message wasn't sent by me and that's false. I would never say nor do terrible stuff like that." He referred to it as a "false rumor" and linked me to a vent post of his

dating back to May 3rd of this year (said vent post essentially just boiling down to "All the claims made against me are false, but I won't actually provide any physical evidence exonerating me, so you'll just have to take my word for it." You can read the post here:

https://gamejolt.com/p/tired-of-this-vent-h4rcm9mg). Keep in mind that I just simply said that I needed to talk to him about something, I didn't bring up the images/proof until AFTER he already implicated himself in them.

Side note: TCE, I know you're gonna read this and attempt to delete that vent post of yours to cover your tracks, and if so, I'll let you know that I already archived the post through screenshots, which I'll proceed to show here for archival purposes. Must say, not a good look to refer to accusations of pedophilia as "drama" and to also feature your apology in your own community.



Edit: And as for the message of me admitting that FNaCSlax2 was right, it's completely fake (Someone must've putted my Xmas themed pfp and my username to their message, to make people believe I said it). Please, pay no attention to those people who send fake screenshots of me saying stuff like that. Thank you.

Some of you remember when I used to vent about the "David" situation almost a year ago. Until some idiots decided to mass report it so that GJ could remove it. It pissed me off when it got removed.

Like I said before: Those allegations about David are FALSE.

What do I mean? Because someone who impersonated me mentioned himself chasing that kid. I was asleep, because my timezone is CET (Central European Time).

If I would EVER do something like that, then I would've admitted that it was me.

How to know that there's an impersonator? Always check someone's username when clicking on the PFP.

Now moving on with the DA (DeviantArt) ones.

Some of you from DA know the Valentino ASMR TW: Abuse. Yes, I voice acted Val. I did made a big mistake though, I didn't address the trigger warning before sending the message with the link of the video.

And as for the SummerBerriBear one, I did apologize and promised to NEVER do that again.



Overall, I did had a convo with a guy named IZach, he shared me words, and told me to Live and learn, and let "People who cutted ties with me" be (Let them be).


@/Spongejoe (Riley Sundae) is right though, both sides are evil. (Both my side and the others' side).

What's gonna happen to FNaS World: Renewed? It's gonna be on hold until a further notice. No, it's not cancelled.




But now, back to the main subject. The screenshot below shows the full initial interaction between me and TCE that I mentioned above the side note, my sincerest apologies if you have to zoom in to read the text better (for further clarification, the number you see on the top-left side of the screenshot is meant to designate the rough order of events in which things happened).




I think the very fact that he almost immediately knew what I was referring to and felt the need to send me a vent post as an attempt to give me context (said context not explaining anything in detail) makes this seem more and more like


an admission of guilt as the days go by. But I digress. In this second screenshot, I had asked him how he could fully know for certain that his message of dating a minor and saying the N-word was fabricated/false, and he himself said that he "doesn't have any proof" and that his account got "hacked" by someone. Notice in his messages that he switches between saying he was "hacked" and saying it was someone who "impersonated" him. I would also like to point out that he subtly tries to persuade me not to look into the topic any further by saying that I "need some rest". If this were something I was accused of, I would've immediately clarified if I was hacked with proper proof, or just simply owned up to it to not appear like I'm dodging the question.




This next screenshot is me directly countering his claims that all of his messages were "fabricated" by pointing out how they all were made at specific dates and were publicly acknowledged in his so-called "vent" post. While these pictures will be brought up as fully-defined evidence later on (and in better quality) in this document, this was just me showing him that images like these are quite hard to fake. Being an egotistical asshole and a racist fetish-laden pedophile aren't exactly things that a "hacker" would implicate on you if it wasn't already true. A hacker would CREATE the posts/images to implicate you, and most hackers don't know the entire background behind the person they hack, so for one of these screenshots to mention someone by the name of "FNACSlax2", it means that you would HAVE to be the only one typing this out. The evidence is just too specific and overwhelming to be anything other than real. Also, note how TCE only acknowledges the pics of proof in regards to being egotistical and admitting to racism/dating a minor, NOT the pic proving his posting of fetish content onto his DeviantArt account (which he didn't acknowledge in his "vent" post).




This 4th screenshot further implicates him, as he tries to tell me that the pictures of proof I was sent of his terrible actions weren't true because he "didn't remember" typing it, not before linking the same exact post he had linked earlier of his "innocence" in all this. He claims that the people who accused him of being a creep were "backstabbers", deflecting his own responsibility to own up to his actions in order to throw others under the bus for reporting his behavior first.




What officially made me realize that TCE was completely full of shit was the fact that, when pressed further about whether or not he was telling the truth, he stated that someone had hacked into his account on March 31st of this year. When I corrected him that he was "hacked" on March 19th, 2023, he just simply stated "And that message wasn't from me". Once again, he tries to persuade me not to look into the situation any further, saying it would "be best" if we just dropped it entirely. I bring up the point about TCE lying to further cast judgment on his claims. Upon catching him in a direct lie, he proceeded to essentially handwave it. It wasn't an error, he didn't correct himself, he just boldly said a complete lie in the hopes that I wouldn't catch it. And again, he brings ZERO evidence to the table to even remotely prove that he was genuinely hacked. If he can lie to someone like me and not feel any sense of remorse (while also pretending to care), he can lie to everyone.




When pressed even more, TCE proceeded to tell the "truth": A completely random and non-relevant story of a "hack" he suffered this year in March 31st (the exact same date he told for his first lie). I'll let the screenshot do the talking for me, but long story short, it's nothing but a cold-faced lie. When I asked yet again if he suffered a hack like that in 2023, he told me, to my face, "I don't know." Bear in mind that just earlier, he was incredibly adamant that he was "hacked" when his message was shown. Suddenly, now it's just "I don't know." I think the most truly baffling thing in this entire screenshot is the fact that he made sure to SPECIFY that the claims made against him were that he dated a 14-year-old and said the N-word. Never did I specifically mention the age of the minor whom TCE was dating (as I didn't know/wasn't told their exact age when being sent the pictures of proof, just that they were a minor). The specificity of the minor's age when it was never mentioned only serves as an even deeper admission of guilt.



I would also like to point out yet another example of TCE's attempts at manipulation. Posting a cheesy GIF of two bears hugging, saying things like "If you ever cut ties with me, then I guess this is goodbye..." and just not admitting to ANYTHING that was accused of you is the textbook definition of pathetic sympathy farming. Truly disgusting how you default to trying to make me feel bad after it was clear that you lost the argument. Frustratingly unserious behavior, straight-up. Even if, by some astronomical miracle, the proof was indeed fabricated, this handling of the situation would be horrible and unprofessional in every sense of the word.




At this point, I was done. I couldn't stand the lies, the deception, and just the overall lack of accountability. As such, I had demanded TCE to delete the collab drawing post, remove my name from his bio, and remove any other mentions of me from his posts (this was what I was referring to earlier in the document when I showed that gift render of his being edited to remove the original mention of my name). Also, in this screenshot, peep the way he tries to guilt-trip me into feeling bad that I won't be selected as a playtester for his fangame. Ah yes, because I should feel bad for not becoming a playtester for a racist pedophile's lame and scuffed fangame that would get realistically flamed to pieces if ever brought into serious discussion. After he removed the mentions and the collab drawing post (and I made sure to fully verify that he did so), I had to ask him for 3 more requests before I was to fully remove him from my sight.



My 3 requests were as follows: Don't bring up what transpired between us, never interact with me again, and stay away from my friends. Yet again, it's important to highlight how TCE attempts to paint himself as the victim, saying "if you'll ever change your mind and want to apologize for a big misunderstanding, let


me know." Yes, you read that correctly: HE told ME to apologize to HIM for a "big misunderstanding". No remorse, no accountability, no acknowledgment of what he was accused of, just one last fuck you/deflection. TCE, saying that I have to be the one to apologize after you spent MULTIPLE minutes completely denying reality because you thought I wouldn't spot your lies is truly laughable. This strategy may work on the average Game Jolt user, but I'm not one of them. After reading what he said, I fully blocked him and updated my friends on Discord about what had happened.



Now, assuming you've read everything up to this point, you might ask me the very valid question "TheLegend87, you've known this information since June, so why are you only deciding to make this public now?", and to that, I have to honestly and truthfully admit that I was scared. Although (like I said earlier in the document) I didn't develop any sort of deep friendship with TCE, I had seen him as a casual associate of mine, and there wasn't anything that I saw or noticed about him that made me put my guard up prior to discovering the crimes he committed. When he gifted me a render (the one shown on page 2 of the document), I deeply appreciated it and it made me fall into complacency thinking that it was genuine, or that someone making me something out of their own volition means they can be trusted. I was genuinely so excited to make the collab drawing with him, and of COURSE if I had known prior that he was a creep, I never would have looked his way!

You have to look at this from my perspective: imagine meeting someone who you thought was cool (or at the very least, harmless) and you fully agree to participate in their drawing collab. You give them updates along the way, and everything seems fine. So then, imagine the look on my face when not even an HOUR after I posted the collab drawing to Game Jolt, I was then informed about TCE's actions through Discord? It would be like making an album with a musician thinking that everything's good and then only finding out after the release of the album that said musician was a racist. It looked incredibly bad optics-wise for me to involve myself with someone like that. After I was told by my Discord friends that he was a creep, I felt scared that people were gonna look at the collab drawing and assume that I had no problem collabing with him or that I KNEW of his misdeeds and didn't care, when that is CERTAINLY not the case. The internet removes nuance/context all the time, and even if I were to immediately make a post after the incident, stating that I had only recently learned the information on TCE being a creep and that I deeply apologize for not knowing sooner, it would've immediately looked suspect even to my closest friends.

All that, combined with the information from my friends that he silences criticism posts against him and that he always tries to farm sympathy after the fact (implying this sort of thing has happened multiple times)...



It would've just been a recipe for disaster, especially with how poorly timed it was. So I got scared in the heat of the moment and told TCE to never interact with me ever again and that we resolved the situation privately, which I now only realize wasn't the right call. I deeply and sincerely apologize for not bringing this matter up to everyone sooner, and had I been less scared, the

situation would've been TRULY resolved months ago (and by "resolved", I mean that I would've made this document earlier so people would have the full context). I completely understand if you think that I could've handled this situation better, and I'm not gonna play the sympathy card like TCE did when called out, I'll fully own up to my mistake.

With all this clarification said and done, however, it's time that we move on to the actual raw evidence regarding TCE's crimes. What you finished reading was the preface behind this entire document, from my history with TCE to what exact events transpired that led to its creation. Now, we're getting into the heart of the issue, and it's at this point where I once again mention that viewer discretion is advised, since certain topics are going to be discussed here that might feel discomforting to some. Let's begin.

Part 1: Admitting to Racism and Pedophilia

The first piece of evidence we're going to be looking at is this screenshot of a comment TCE made on March 19th, 2023.



In it, TCE states that someone by the name of "FNACSlax2" was correct when he stated that he dated a minor and said the N-word. TCE defends his actions by saying that "the heart wants what the heart wants" and that "he deserved it I tell you!" In his vent post that I had shared with you earlier, he had this to say about its validity.

Edit: And as for the message of me admitting that FNaCSlax2 was right, it's completely fake (Someone must've putted my Xmas themed pfp and my username to their message, to make people believe I said it). Please, pay no attention to those people who send fake screenshots of me saying stuff like that. Thank you.

Alright, so let's somehow assume that TCE is telling the truth and that it WAS faked/doctored: where's the proof? All we have to go off on is TCE's word, which doesn't really mean anything. If I were accused of something like that, I would make sure to record video evidence or photographic evidence that I never admitted to those things. The other big question is that if this WAS the result of a hack (the second excuse TCE gave), then why would the hacker only stop at making you admit the crimes you were accused of? Correct me if I'm wrong, but typically, most hackers don't just stop at making their victim look bad. If someone genuinely managed to hack into your Discord account, they would've absolutely done/said a lot worse. You can't just say that someone hacked you or doctored some images together without any evidence. Also, if someone managed to hack into your account, how would they even know who "FNACSlax2" was? That seems like a highly specific name that the hacker wouldn't know about. Presumably, only YOU would know who that is, which gives more support towards the fact that the image is real. The highly specific date of March 19th 2023 isn't helping matters either, AND the "Wave to ToyChicaEntertainment" option in the chat log implies that the recipient is someone YOU went out of your way to message first. I must say, you seriously aren't helping your case here. You saying in your vent post that "someone must've" framed you just makes your validity even more fraudulent. Did they do it or not? One more thing: I already pointed it out earlier, but peep how TCE specifically refers to the minor he was accused of dating as being 14 years old, despite that fact not being brought up by me or in the evidence. Does this sound like an innocent man to you?

I don't know. But all I'm saying is, that this message of me saying that I dated a 14 year old and saying the N word is FAKE. I may not have screenshots of proof, but I know I didn't said anything like that. I would NEVER say something like that.

And please, I ask you nicely, pay NO attention to that screenshot.

I know I'll have people tell me how this shouldn't matter because the comment was made 2 years ago and will argue that "he's changed". But here's the thing: I don't see any of that "change". The TCE of 2023 is no different than the TCE of 2025. He never apologized, he never owned up to his mistakes/inconsistencies, and he never just came clean and told the full truth on anything. I've said it before and I'll say it again: If he could lie directly to my face when pressed (and pretend that I won't notice it), imagine how much he could lie to you? Don't assume that this man isn't capable of lying because you "know him". Don't fight for someone you don't know personally. Also consider that he's been known to silence all forms of criticism against him. If someone was TRULY innocent, they wouldn't need to silence shit. And this is where we move on to the second part of the evidence: TCE's "nice guy" facade.

Part 2: Being Egotistical

While this isn't on the same level as confessing to racism and dating a minor (saying so would be frankly ridiculous), this next piece of evidence mainly serves as a way of dismantling TCE's image of being a "nice guy".




In the screenshot above (apparently dating back to August 8th of 2022, per TCE's own words), TCE states that "At least I'm better than all of you in this server, at Game Jolt". A few minutes later (presumably after being pressed for his rudeness) he corrects himself by saying that he only meant being better than them in the "FNAF tycoon server." When told that this doesn't remove how rude he initially acted, he just simply states "Welp, there goes my fame." In the screenshot, a user by the name of JamelTheCamel points out that TCE only cares for himself and that he "really should've done a background check on who you are." I want to point out that in TCE's vent post, out of everything that he was accused of, being really rude was, according to him, his "Worst mistake". Oh no, it wasn't being a racist who said the N-word, it wasn't being a pedophile who dated a 14-year-old girl, it was just simply being a bit angry that was his "worst mistake". I couldn't make this up if I tried.

First time was in 2022, 8th August. It was when I had a frustrating morning and was because someone from the other telling me to STFU (Shut the F**k up), someone who has sent horrible edits of my old pfp (That I claim them as vandalism), after a little beef with that guy, I made a mistake and said "At least I'm still better than all of you at GJ", which it made people think that it was targetted at every person of GJ. Worst mistake, TCE.

Once again, before you try to tell me that this was 3 years ago so it doesn't mean anything now, I'll remind you the fact that TCE has fundamentally not changed in the span of those 3 years. He would've done this no matter what year it was. The very fact that THIS was the one thing he admitted to doing doesn't benefit his case, and in fact, it hurts it even harder. It's not a good look when you're admitting to something this insignificant while conveniently handwaving the truly serious accusations that have been thrown your way. If TCE thinks admitting to this would somehow smooth everything else over, he's sorely mistaken. The only type of people who would fall for this sort of thing are little kids, which is the exact type of audience that TCE has cultivated/catered to. I want you to just simmer on that idea for a minute or two.

<u>Part 3: Making Inflation Art of an Underage</u> <u>Character, While Also Being Underaged Himself</u>

Also included in the evidence I received was this (now deleted) render TCE posted onto his DeviantArt account, seemingly dating back to October 1st of 2023. It depicts an inflated Toy Chica and Coco Bandicoot (from Crash Bandicoot) as well as TCE's OC Octo Steven. For those who are unaware, inflation is a fetish where a person's stomach gets expanded to massive levels, which sexually arouses those who also have the fetish.



An inflation fetish is a sexual interest in the act of inflating or being inflated, often involving the body or specific body parts. This can include:

Inflating oneself: Using air, water, or other materials to expand the body or specific areas, such as the stomach, breasts, or buttocks.


Being inflated by another person: Consenting to being inflated by a partner, who may use pumps, balloons, or other methods.

Watching others being inflated: Observing others engage in inflation activities, either in person or through videos or images.

The date of that render being uploaded (October 1st, 2023) is important because just a few days ago (6 days ago to be exact, at the time of this document's publish date of October 9th), TCE made a post celebrating his 19th Birthday.




If the inflation render was indeed posted on October 1st of 2023 (and TCE's Birthday is indeed on the 3rd), then TCE was only 17 years old at the time it was made. This would make him underage and not legally allowed to draw/partake in fetish art. Before you ask, yes, I did the math.



I don't think I need to explain why someone making fetish art at 17 years old is inherently a bad thing. Combine that with the naturally young audience that TCE had cultivated (and has since continued to cultivate), and it sets an incredibly bad precedent of underage children being exposed to things they shouldn't know about until they're of age. And before you say that him deleting it means that he felt bad and wanted to change, I'll remind you that to TCE, the idea of change isn't actually about improving yourself for the better, but to simply handwave all forms of criticism under the guise of "not knowing better". I can guarantee you that he didn't delete that render out of guilt/regret, but out of panic that he was going to get in trouble.

And as for that "underage character" statement that I mentioned in the title, I'll fully elaborate on that: Coco Bandicoot is Crash Bandicoot's little sister, and according to Charles Zembillas (a concept artist who helped work on the Crash games), Coco Bandicoot's age was never officially stated, but she's a "young little sister girl probably in her teens". I think "young little sister girl" sums it up best: Coco Bandicoot is most definitely underage, and no matter the age of the artist, it's just not right to depict minors in fetish-related artworks. And before you claim that it's "fictional" and that it's "just a drawing/render", I would like to ask you: it's a render of what, exactly? If it's just a render, then go ahead and describe the render in detail. Oh wait, you can't, can you? Hmm, it's almost as if describing it (a little girl with her stomach inflated for others' sexual pleasure) probably wouldn't help it stand in court. I rest my case on the matter, it's really self-explanatory. Before I move on to the next part, I'd like to highlight the fact that TCE didn't address this in his vent post at all.

This is without question the most deplorable act in this entire document, and I find it quite frankly appalling that TCE was able to say this without consequences or even an OUNCE of regret. Per his own words, a few days after the argument that he referred to as his "worst mistake" (which I talked about in Part 2), he hosted a Q&A stream where people could ask him questions about his fangames and characters. Well, at one point in the stream, someone had asked "Do you like kids?", to which TCE said "Uhh, yes." According to him, he meant that in a "normal" way, and that he wasn't some "weird person who is addicted to them."

Then few days later, I had a QnA stream, where some people asked me questions about my fangames and characters. Then there was one which it was controversial in this generation (That one sucks, trust me. You'll see why).

The question was: Do you like kids? I replied: Uhh, Yes.

And I'm here to clarify what type of yes I meant. I meant yes, but as a normal person. Not some weird person who is addicted to them.


I mean imagine someone so oversensitive and overprotective asking you if you like kids, and you say yes, they'll just gasp in fear and run away from you to alert everyone that you like kids. Pretty stupid, isn't it?

This is why I don't like this generation, where people, not just them, but also content creators just get involved with drama, just like DAgames, or Jonochrome, or SummerBerriBear (Do not support these).

Before we can even unpack the utter mess that was that entire quote, it's best that I actually show you all the moment that TCE was referring to: Here's the link to the video (clicking on it will let you download it:

Before you say that I wouldn't be allowed to criticize this because he was only 16 at the time of it being recorded completely ignores just how bad it actually is. First of all, the person who asked TCE that question was JamelTheCamel, the same person who was shown in Part 2 calling TCE out for his egotistical attitude. The very fact that he asked that and specifically said "so do you actually like children?" implies that this wasn't the first time TCE was asked something like this. Second of all, why in the world did he answer the question like that? If someone were to go up to you and ask "do you like children?" and you paused for 3 seconds before saying "yes", your hard drive would have to be checked. And before you ask "what else was he supposed to say in response to that?", I'll tell you what he was supposed to say: NO! That wasn't some completely random/casual question like "do you like pepperoni on your pizza?", where you don't know how exactly to respond because it's so vaque. That was a seriously loaded question with energy and intent behind it, and there were only 2 answers to it: yes or no. JamelTheCamel didn't ask that for fun, he asked that for an answer, and TCE should've immediately said no. Anything else, and you're just digging yourself deeper into a hole you won't be able to get out of. TCE framing people being upset at this as them being "oversensitive" and "overprotective" just proves to me that he will never be able to just own up to ANYTHING. It makes me sick.



It wasn't a good look in 2023, and it certainly isn't a good look in 2025. I bring this all up to show how TCE is not only a morally bankrupt person, but also surrounds himself with the low-lifes of the world. Is this someone who deserves a following of over 3,630 people? Oh yeah, and did I forget to mention that TCE didn't address this in his vent post at all?



<u>Conclusion: A Moment of Truth</u>

It took a lot of documentation and general proofreading, but I believe I've officially finished presenting all the evidence I had against TCE. I find him to be truly despicable, and it deeply frustrates me how he's gotten such a large following on both Game Jolt and DeviantArt. Before I found all this out, I (like many others) had thought of him as a decent enough guy who seemed to be charitable, but it's only now that I fully recognize him for what he really is: a racist pedophilic transphobe defender. He hides his crimes with guilt-trips and

passive-aggressive remarks, and actively silences any and all forms of criticism through post deletions.

To TCE, if you're reading this (which is most definitely likely), I'll leave you with this message: **get help**. You don't deserve a platform, and I don't care if you were underage when you committed the acts you did, because you've clearly shown that you don't plan on changing anything about yourself. You're still the same weirdo you were in 2022, and unless this document can compel you to change your ways (which I highly doubt given what's been established), that's what you'll continue to be. Even if, by some astronomical miracle, you were in fact telling the truth about people fabricating evidence against you, you still wouldn't be able to answer for the other crimes you failed to bring up in your vent post. Despite everything I said today, I do genuinely want you to improve and become a better person. But that requires reflection, something I don't think you've ever done.
