Whereas, The Act for Registration of Student Organizations is in need of updates; and,

Whereas, The Committee has maintenance of the Act for Registration of Student Organizations.

Therefore, be it enacted by the Student Senate of the University of North Carolina at Charlotte, as follows:

SECTION I:

§7-1.10. Registration.

(b) All undergraduate student organizations must maintain at all times at least eight students who are participants within the group, and provide a **complete and accurate** list of members along with their registered email addresses online in Niner Engage. ~~In the case of hybrid campus operations, organizations can request an exemption from the 8-member requirement.~~

SECTION II:

§7-1.14. Student Organization Resource Center.

Organizations may use computers, meeting space, resources, supplies and library materials made available to them in the Student Organization Resource Center, located in the ~~Student Government and Organizations Complex~~ **Center for Student Involvement** in the Student Union.
