Admissions Policy

- We admit students of any race, color, or ethnic origin to all the rights, privileges, programs, and activities generally accorded or made available to other students at the school. - Admission cannot be granted until all necessary records have been submitted to the school office and a personal student/family interview with school administration has been completed.
- Students entering Kindergarten through Twelfth grade will be tested at the administration's discretion prior to admission. At least one parent/guardian must be a born-again Christian who knows the Lord Jesus Christ as Savior and can give a clear Christian testimony. The parent/guardian faithfully attends, financially supports and ministers in a local church whose fundamental beliefs are in agreement with the Statement of Faith of FBA.
- The parent/guardian accepts without verbal or mental reservations both the Statement of Faith and the Educational Philosophy and Objectives of this school and is committed to upholding them.
- All admissions appointments will be made on a probationary basis and continued enrollment at the Academy will be contingent upon demonstration of student adherence to our 4 Guiding Principles.
- Preschool & Kindergarten students must be age 3, 4, or 5 by September 1, and must be developmentally ready for our programs.
- A member or members of the School Administration and/or faculty will interview all new middle/high school students.
