SECTION 1: INTRODUCTION

2.1 Information You Provide

We collect information you voluntarily provide including name, email address, phone number, postal address, payment information, and any other details you submit through registration forms, contact forms, or your account.

2.2 Automatically Collected Information

We automatically collect IP address, browser type, operating system, pages visited, time spent on pages, and referring URLs using cookies and similar technologies.

2.3 Payment Information

Payment information (credit card, banking details) is collected by our secure payment processors. We do not store full credit card numbers on our servers.

We use collected information to provide services, process transactions, send marketing communications, improve our website, conduct research, comply with legal obligations, and prevent fraud.

SECTION 4: COMMUNICATIONS & CONTACT CONSENT

4.1 TCPA Compliance

By providing your phone number, you provide EXPRESS WRITTEN CONSENT under the Telephone Consumer Protection Act (TCPA) to receive SMS texts, calls with autodialers, prerecorded messages, and AI voice agents. Your consent overrides the National Do Not Call Registry.

4.2 SMS/Email/Call Opt-Outs

You can opt out of SMS by texting STOP, email marketing by clicking unsubscribe, or calls by telling the agent. See Section 4.4 below and our Communication Consent Addendum for complete opt-out procedures.

4.3 Email Privacy

We comply with the CAN-SPAM Act (15 U.S.C. § 7701). All marketing emails include our physical address and an unsubscribe link. You may opt out within 10 business days.
