# **High School: Hybrid Model**

To ensure physical distancing in classes and within school buildings, students will attend in-person classes two days per week (Monday/Tuesday or Thursday/Friday) and virtual classes three days per week.

# **Safety Precautions**

- Smaller class sizes will be employed to better ensure physical distancing within the classroom and the school building.
- Reduced number of people a student comes into contact with during the school day.
- Students and staff members wear face coverings/masks when on school property.
  - Student needs related to face coverings/masks will be addressed on an individual basis.
  - Students will not wear a face-covering/mask during meals.
  - A clean face-covering/mask will be provided each day for students who do not bring one from home.
- Classrooms will be cleaned daily and disinfected on Wednesday and over the weekend (between the two groups of students).

### **Arrival**

- Students will utilize multiple, designated entries where they will disinfect hands upon entering the school.
- Students will enter the building using physical distancing practices.
- Clean face coverings/masks will be provided for students to pick up if they need them prior to going into the building.

# **Hallways**

- If possible, traffic will flow in the same direction. Hallway transitions will be minimized and will occur for certain classes and programs.
- Students will use physical distancing practices and will be required to wear face coverings/masks while traveling the hallways.
- Tape traffic flow markers will be located throughout the building as will additional signage.
- No single drinks from water fountains will be allowed.
  - Water bottle refill only
  - Potential to have single-use cups

#### Classroom

- In the classroom, students will wear face coverings or masks and will wash/sanitize their hands before entering and upon leaving the classroom (District supplied and student safe products only).
- Student school supplies will not be shared. Shared classroom supplies or instructional materials will be guarantined or disinfected before use by another student.
- Schedules will be created to reduce the movement of students if possible, along with additional passing time considerations.
- Students will remain in their desks until dismissed by the teacher and be released in a way that reduces the number of students entering hallways at one time.
- Students will wipe down their desks prior to leaving the classroom (District supplied and student safe products only).
- During physical education classes, no face coverings/ masks will be worn (per CDC guidelines). Outdoor spaces will be utilized as much as possible when weather permits.

## Music/Band/Orchestra/Choir

- Students will wear face coverings or masks unless using a wind instrument and will
  wash/sanitize their hands before entering and upon leaving the classroom (District supplied
  and student safe products only).
- Spit valves for instruments will be emptied into a puppy pad.
- Bell covers will be utilized as "masks for instruments" when played.
- Large spaces and pod structures will be utilized when possible with physical distancing guidelines in place.

## **Art/Tech Ed/FACE**

• Large spaces and pod structures will be utilized when possible with physical distancing guidelines in place, along with a specific cleaning process for shared tools (workshop, culinary, art tools, etc.).

#### Meals at School

- Breakfast and lunch will be served from multiple stations in the building using a grab and go format. For lunch, multiple eating sites, including classrooms, may be used to reduce the number of students in one area at one time.
- While eating, students will face in the same direction with physical distancing guidelines in place. Students will wipe down their space after meals using district supplied and student safe products only.
- Face coverings will not be worn while students are eating.
- Washing/sanitizing of hands will occur after meals.
- Lunch hours could be paired with student advisory groups.

# Release at the end of day

- Students will remain in classrooms until dismissed by staff.
- Staggered release time of classrooms will be used to limit hallway crowding at the end of the day.

- Students will utilize designated exits where they will disinfect hands upon leaving the school (wipes or hand wash station).
- Face-covering/mask collection will occur for those students who received one upon arrival (washed/return).
- Physical distancing will occur while students wait for the bus or pick up.

### **Bathrooms**

- Students will wear face coverings or masks and will wash/sanitize their hands before and after using the bathroom.
- Procedures will be put in place to limit the number of students in a bathroom depending upon available facilities.

### **Locker Rooms**

- Students will wear face coverings or masks and will wash/sanitize their hands before and after using the locker room.
- Hand sanitizer stations will be increased.
- Procedures will be put in place to limit the number of individuals in a locker room at one time.

## **Field Trips**

- Only virtual field trips will be allowed at this time.
- Only virtual school assemblies and events will be allowed at this time.
