## Excellence In Education for All Students 2021-2022 AHS Student Dance Contract

**IMPORTANT!!!** I understand that **MASKS** are required (even outdoors at this time at school). – **If** anyone tests positive for COVID and was at the dance, ALL people attending the dance would be a part of group-tracing. All students will monitor for symptoms and stay home if symptoms occur. All students would be expected to rapid test students 3-5 days from the exposure.

The following rules must be adhered to during the 2021-2022 school dances. I, the undersigned student of Arcata High School (AHS), agree to the following:
□ I will not transfer my dance ticket to any other student.
□ I will provide a negative COVID test 48 hours prior to the Dance.
□ I understand that dance tickets are non-refundable.
<ul> <li>I understand that I and my parent/guardian must sign this contract and provide a contact number before I purchase my dance ticket.</li> </ul>
□ Guests will need a completed contract by 4:00 pm on Wednesday, March 2, 2022.

On the night of the dance: I understand that the AHS staff, with the assistance of the supervising community chaperones, will enforce all of the rules and regulations of the school.

- □ I will not use alcohol, tobacco, or drugs before or during the dance. I understand that school administration will enforce consequences for my choices. **AN ALCOHOL SENSING DEVICE MAY BE USED DURING THE DANCE.**
- □ I understand that school personnel may search students if they suspect school rules were violated.
- □ I understand there is no admittance to the dance after 10:30 p.m.
- □ I understand there are no re-entries. If I leave the dance for any reason, I may not return. Loitering in the parking lot is prohibited.
- □ I understand that I may be asked to change my clothes if they don't meet the school's dress code.

<u>Conduct at the dance</u>: I understand that the manner of dancing will be appropriate for a school function. Sexually-explicit or any other type of dancing which could be construed as vulgar or provocative is prohibited. This includes dancing styles that involve intimate touching of the breasts, buttocks, or genitals, or that simulate sexual activity. Dancing such as freaking, grinding, and mashing will not be tolerated.

## Consequences:

- □ I understand that if I violate the AHS Dance Contract, I will be verbally warned and removed from the dance if repeated infractions occur.
- I understand that my parent/guardian will be called and expected to pick me up immediately.
- □ I understand that I may not be eligible to attend future dances.
