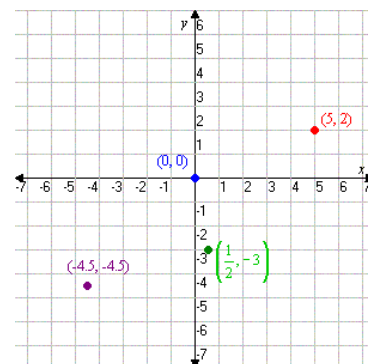


Fig. 1. Example of a figure caption. (figure caption)
