Privacy Policy

Information Sharing

We share your information with third-party service providers for the purpose of providing the Service to you, to facilitate our legitimate interests or if you consent. These service providers are vetted by us, and will only be provided with access to your information as is reasonably necessary for the purpose that we have engaged the service provider. We require that such third parties comply with applicable laws, and have security, privacy and information retention policies consistent with this Policy to the extent necessary for them to perform a business or technology support function for us.
