GENERAL

Creating good work requires the right time, place, and people. Not every commissioned work will always meet everyone's expectations. For those people who like my art work and commissioned me, thank you for your support!

Please send me the details about your commission and some references.

Happy to receive a really rough sketch from you, just to know the composition or poses you want . (this is unnecessary but will help)

PAYMENTS

via Paypal or Vgen.

You can pay full or split payment to 2 sections.

- full payment once I send a fee proposal.
- split payment, You can pay me first half when the fee proposal is accepted, the remaining balance to be paid once commission finished. A small drawing with watermark will sent to you for final check, and full drawing without watermark will be sent to you once payment is received.

PROCESS

- 1. rough sketch, I will show you the rough sketch and you can change everythings here if there something is not look like your request.
- 2. clean up sketch, if necessary (minor change/revision if something needs to change with poses, etc., ask here to).
- 3, LineArt/base color, you only can take minor changes/revision here. Note that not every illustration will have lineart, it may just have a clean up sketch with base color.
- 4. Final Client to check for any final details. Only minor details are allowed to be changed here.

DEADLINES AND DELIVERY

To be agreed by both parties.

USE

The commission should only be used within the boundaries of what was agreed on.

USAGE AND CREDITS: COMMERCIAL USAGE

Once agreed upon, the commissioned artwork can be used by the Customer for commercial purposes under the following pricing tiers:

- 1.5x Price Tier: The Commissioner may use the artwork on monetized platforms such as TwitchTV and YouTube. It is required to provide proper credit to the artist by including a statement like "Art by Hyanna Natsu". The price for this tier is 1.5 times the original commission price.
- 2x Price Tier: In addition to using the artwork on monetized platforms, the Commissioner is permitted to sell merchandise featuring the artwork. This pricing tier is specifically designed for small businesses. The price for this tier is 2 times the original commission price.
- 3x Price Tier: This tier is intended for big businesses or high-selling products. The Commissioner can utilize the artwork for commercial purposes and expect significant sales. The price for this tier is 3 times the original commission price.

INTELLECTUAL PROPERTY RIGHTS

You MAY NOT use the commissioned work for NFT related usage.

You MAY NOT use the commissioned work for AI training purposes.

You MAY NOT reproduce the image into a merch / prints / digital inputs intended for commercial purpose. However for personal use is fine.(Unless this is a commercial commission from first)

The artist retains all rights to the artwork.

Artist reserves the right to display commissioned artworks on social media/portfolios unless NDA option is chosen.

Client only obtains the right to use the artwork for the purpose agreed upon (personal/commercial) upon full completion of the commission i.e. client is NOT allowed to use the artwork if they decide to cancel halfway.

REFUNDS

NO refunds of existing completed and approved stages.
