This Implementation Agreement is entered into force on 21/July/2023 by and between:

1. Dr. Mohammad Ahsanuddin, M.Pd: Head of Department of Arabic, whom therefore legally represents and acts for and on behalf of the Study Program of Arabic Teaching, Faculty of Letters, Universitas Negeri Malang, whose address is at Jalan Semarang 5, Malang, hereinafter referred to as Party I.
2. Dr. Romzy Morkhi: Head of Arabic Program Study, whom therefore legally represents and acts for and on behalf of the of Arabic Program Study, Faculty Humanities and Social Sciences, Yala Rajabhat University, whose address is at 1st Floor (Right Wing), Social Sciences Building (No. 24)
133 Tesabal 3 Rd., Tambon Sateng, Mueang District, Yala, hereinafter referred to as Party II.

PARTY I and **PARTY II** hereinafter referred to collectively as **THE PARTIES**. The Parties hereby agree to jointly arrange an Implementation Agreement on the program Visiting Doctor Organized by **THE PARTIES** as regulated in the following articles.

Article 1 **PURPOSE AND OBJECTIVES**

- (1) The purpose of this Implementation Agreement is to serve as the basis for the Implementation Agreement arranged by **THE PARTIES** in accordance with the scope of this Implementation Agreement Regulation.

Article 2
SCOPE OF ACTIVITIES

- (2) The implementation of cooperation for this agreement is carried out by with mutual consideration.
- (3) **THE PARTIES** shall monitor the implementation of the program visiting doctor not less than 2 (two) times in one period of activity.
- (4) **THE PARTIES** are to carry out visiting doctor as stated in the attachment 1.

Article 3
FUNDING

The amount of funding for this Rp 3.000.000 activity is visiting doctor and is charged to each **PARTY**, which originates from DIPA in the amount of Rp 3.000.000

Article 4
DURATION

This Implementation Agreement of cooperation is valid from 21 July 2023 until 24 July 2023.

Article 5
CLOSING

- (1) Any amendment to this Implementation Agreement shall only be made with the mutual approval of **THE PARTIES**.
- (2) This Implementation Agreement is deemed to be terminated if one **PARTY** or **THE PARTIES** fail to fulfill the provisions in this Implementation Agreement.
- (3) Particulars that are not / yet to be determined in this Implementation Agreement shall be addressed further by **THE PARTIES** on the basis of mutual discussion and agreement which shall be set forth in an Addendum, which is an integral part of this Implementation Agreement.
