

## Schedule of Fees and Charges - Effective 1 April 2025

We operate under The Building Act 1984, The Building Regulations 2010 and The Building (Local Authority Charges) Regulations 2010, The London Building Acts (Amendment) Act 1939. London Borough of Hackney Building Regulations Charging Scheme, No 3, 2017

## **Building Regulations Application Fees**

### **Standard Charges Categories**

Table A: 1 – 5 New Houses

Table B: Alterations and Extensions – including extensions, lofts, basements and electrical

wiring.

Table C: Cost of Works – for works from up to £100k

### **Application Types**

#### 1. Full Plan -

- a. For Tables A, B certain larger works and C where cost of work is £10k or more fees are broken down into two parts plan assessment fee and the site inspections fee. The Plan assessment fee is paid when submitting the application and the inspection fee is invoiced following the commencement inspection.
- b. For Table B certain small work and Table C where cost of work is under £10k there is a single fee payable at time of submitting the application.
- 2. Building Notice fees are paid when submitting your application.
- **3.** Regularisation and Reversion applications Are charged at 120% of the Building Notice charge but do not include VAT. Fees payable with the application.

#### **Notes on Fees**

**Multiple works** – Where plans show more than one item of work, such as two separate extensions or an extension and a loft, the fee is payable for each part minus a 10% discount. **Cost of works** – This means a reasonable estimate that would be charged by a professional builder but excluding professional fees and VAT.

**Exemption** – where the work is to provide access and facilities in an existing dwelling or is an extension to store or provide medical treatment for a disabled person, no fee is charged. **Supplementary Charges** – The fees have been set on the basis that the design and building work is undertaken by a person or company that is competent to carry out the relevant design and building work. If they are not, the work may incur supplementary charges.


