



Aesthetic Injection Training

Hands-On Training Terms of Registration

1. Eligibility

You (as participant) must be 18 years of age or older to participate in the hands-on course offered through MedAesthetics, PLLC dba Aesthetic Injection Training ("AIT" and the "Training"). You will need sufficient fluency in the English language and must have the legal authority in the state of Colorado to administer aesthetic injections and/or PDO Threads in a supervised or unsupervised capacity and must be licensed to inject human subjects under the laws of Colorado to administer any treatment or injection during any class. Individuals lacking requisite Colorado licensure may only attend classes as observers. If your legal authority requires supervision from a licensed medical professional, your supervising professional will be required to complete the consent Exhibit A, which will be emailed to you after registration. Additionally, all liability for injections performed by the registrant will fall under the registrant's own medical malpractice insurance policy.

2. Payment / Registration

The fee for the Training (the "Fee") must be paid in full at the time of registration. Registration is not complete until AIT has received such full payment of the Fee. You are responsible for non-payment, even if the Fee is being paid by a third party. After successful registration, you will receive an email from AIT acknowledging your enrollment in the Training.

The Fee consists of a registration fee and participation fees. Courses will be billed in United States Dollars (USD). Accepted payment methods are MasterCard, Visa, Discover and American Express.

You agree to provide accurate and complete registration information. Submission of your registration, alongside full payment of the Fee constitutes your acceptance of these Terms of Registration.

3. Provision of Medical Model

As a condition of participation in the Training, you will be required to provide your own, human healthcare model who will be required to attend the Training and receive treatments from you therein. As a condition of registering in and attending the Training you will be required to review your model's health history with your supervising medical professional and evaluate the appropriateness of the treatments covered in the Training on your model with your supervising medical professional and discuss the healthcare risks thereof with your model. Your healthcare model is required to complete the consent documents Exhibit B as a condition of your participation. Exhibit B will be emailed to you after registration. You will only be allowed to attend a Training as an observer until such consent is obtained.

4. Cancellations and Refunds

Cancellation by You. You have the right to cancel your registration in the Training at any time within three (3) days of your date of purchase. You shall receive a full refund of any payments you have made, unless such cancellation is made within twenty (20) days of the commencement of the Training. To cancel or reschedule, please contact us at least 20 days prior to Training. Cancellations received 20 days or more prior to Training will receive a 50% refund, cancellations received less than 20 days prior to Training will forfeit the entire Training fee.

To exercise your cancellation rights as set out above, please inform us in writing, either by email to info@aestheticinjectiontraining or by mail to: AIT, 5950 S. If you cancel your registration in the Training at any time except for the window described above, you will not be entitled to any refund, except in exceptional circumstances, which will be entirely at the sole and exclusive discretion of AIT. If a refund is granted to you at the discretion of AIT, an administration fee of 5% may be charged.

B. Cancellation by AIT

AIT reserves the right to cancel the Training by giving you notice in writing (including by email) at any time before the Training is due to start, on account of registration or the availability of trainers. AIT will refund all fees paid by you and if possible, will endeavor to offer a transfer to another training as an alternative, subject to payment or refund of any difference in purchase price.

5. Training Content

The training description is intended to indicate only the general nature of the training and does not guarantee content. AIT reserves the right to amend the training and alter details at its discretion. The content of the training has not been reviewed by any professional trade association or pharmaceutical manufacturer.

6. Registrant Conduct

You are expected to conduct yourself in a polite and professional fashion while attending the Training, to immediately respond to the direction or redirection of trainers and to refrain from any disruptive behavior.

7. Digital Content

As a result of your registration in the Training, you agree that you have completed the online Aesthetic Injection Training videos and review questions through a website owned and maintained by AIT (the "Website"). As a condition of registering in the Training and accessing the Website you will be required to agree to the further Terms and Conditions.

8. Miscellaneous

Your contract with AIT and any dispute arising from it (including non-contractual disputes) shall be governed by and enforced pursuant to the laws of the State of Colorado, without regard to conflicts of law. All disputes, litigation, proceedings or other legal actions by any party in connection with or relating to these Terms of Registration or any matters described or contemplated in these Terms of Registration shall be instituted

in the courts of the State of Colorado or of the United States in the State of Colorado, in either case sitting in Colorado. Each Party irrevocably submits to the exclusive jurisdiction of the courts of the State of Colorado and of the United States sitting in the State of Colorado in connection with any such dispute, litigation, action or proceeding arising out of or relating to this Agreement.
