GENERAL

★ I reserve the right to reject any commission without having to provide a reason.

WILL DRAW:

- ✓ All genders, ages, and body types
- ✓ Human(oid)s and Anthros/furries, MLP Pony characters
- ✓ Mild Gore (cuts, bruises, flesh wounds, scars)
- ✓ Suggestive/Sexy poses, themes, outfits, pinup, etc. (Adult OCs and commissioners only)

WILL NOT DRAW:

- ✗ NSFW, graphic gore, explicit content
- ✗ Complicated robots and mecha
- ✗ Offensive symbols & imagery

PAYMENTS

- ★ Please make your payment within 48 hours after I accept your commission request.
- ★ Full payment must be made up front. I will only start working on your commission AFTER receiving payment.

REVISIONS

- ★ Major revisions (Ex. Pose, hairstyle, outfit, etc.) must be done during the sketch phase. After this point, I will only do minor revisions (Ex. Slight color changes, a couple small accessories or tiny details). An exception to this is when I make a mistake that requires a big revision, as I always want to deliver an accurate product.

DEADLINES AND DELIVERY

- ★ Please allow me 2 weeks to 1 month to complete your commission. This range depends on the complexity of your commission or where you are in my queue.
- ★ This time range also depends on how fast our communication is. For example, If you take several days to approve each step, this might lengthen the time it takes to deliver a final product.

USE

- ★ Please credit me when you repost my art
- ★ Do not claim my art as your own or someone else's
- ★ Do not remove my watermark
- ★ The base price is for personal use only. Using my artwork for monetized content and/or commercial merchandising requires an additional fee!
- ★ I do NOT allow my artwork to be made into NFT's or to be fed into or altered with AI.

Personal Use Includes:

- ★ Profile pictures or social media banners
- ★ Posting on your socials
