  - Survey respondents are all Davidson County residents but may not be MNPS students, so cannot match them to high schools
- Clearinghouse results overview
  - DOES NOT include TCAT students
- Group Discussion
  - It's easy to get discouraged and focus on numbers, but remember this is a SYSTEM and there's so many moving parts
  - Concerned with number of hours students are having to work
    - How do housing and transportation fit in to this? Gave example of MOBC's ARC program offering furnished housing close to campus for TCAT students
  - It's important to talk about 1) why students aren't enrolling and 2) what happens after completion of degree as well
  - MTSU: A lot of MTSU students' challenges are also work and mental health
    - Solutions are not one-size-fits-all, but students need to understand what potential solutions are
  - GRAD/FLEX students have support and have made it to college what about the students who don't and haven't?

  - Are our students melting at a high rate because we're advising at a compliance level vs critical customized conversations?

### Summer 2023 Reflections

- Overall observations
  - Persist
    - campus-specific meetups didn't really work, may be a timing issue
    - Identity-specific gatherings were more successful
  - MTSU Scholars Academy:
    - very well organized
    - students were more prepared, eager, energized
  - Overton:

- calling students, supporting transition. Phone calls are a great way to engage students.

#### GEAR UP

- overnight experience at Belmont University (pre-summer melt work)
- Feedback loop with NSCC on application pipeline seems like low hanging fruit;
   not the same for all higher ed partners
- Declining interest in higher ed at some NSR schools
- Avoid one-size-fits-all and drive individual student conversations
- 1. Self-actualization delayed, 2. Gaps in knowledge of postsecondary options (and process), but specifically technical school

#### - Thoughts/Ideas

- NSCC black male initiative (could use an update on this may have one by next meeting)
- Identity-specific program design and marketing
- Creating a space for gathering, relationship-building, near-peer mentor group
- Initiative for Latino males (all age levels) near peer mentoring
- Do we need to keep melt conversations going longer?
- Enhance cohort model through mentorship, alumni
- TCAT in person orientations geared towards MNPS graduates and a Fall Preview Day
- MTSU: focus on MTSU Upward Bound rather than Scholars Academy since SA recruits students unlikely to melt
- Asset mapping. What is already going on, what can we tap into? What are the gaps, what's missing? (GEAR UP working on this)

#### - Successes

- Identity-specific programming
- On-site orientations enhanced students' comfort level with college enrollment
- TCAT senior nights showed them campus and gave them an opportunity to explore campus and really see what we offer
- Summer NSCC/TCAT DE courses are a growing interest area, but unsure of how this impacts summer melt

#### - Surprises and Challenges

- University MNPS barriers beyond financial aid (transportation, housing); also difficult to get in touch with some students after they graduated from MNPS, Vandy study
- Need to pay students to show up
  - Expectation of bringing money into the household
  - Losing work time can be a barrier
  - How to fund this?
- Supreme Court decision around affirmative action
- School-based staff don't always know how best to support MNPS graduates and hand-off to college partners
- Communication with students by colleges doesn't always connect the school-based staff

- Students do not know how to leverage summer to their benefit
- Families have other expectations of how students' time should be used
- How can this WT be most helpful in planning for next year?
  - Professional development offered to team members and NSR project team members.
  - Clear visual artifacts that inform on process and what to expect
    - Translated to other languages
  - Pro-active outreach, handoffs in the spring semester
  - Support in mass communication of things happening next year

### Early Planning for Summer Melt Activities

- What do we mean by "early"?
  - Depends on the barrier that the student is facing
  - Affordability
  - Early exposure (ideally rising middle schoolers) to on-campus experiences, seeing themselves represented on that campus
  - Promote summer engagement in Jan/Feb of the school year
- Who are our target audience(s)?
  - Parents, guardians, caregivers
  - Educate the community on 1st gen student needs and support to make the leap to postsecondary institutions
  - School counselors would help identify students that don't fit in the "go-to" categories
  - Identity-specific groups that aren't necessarily race-based (low SES, disability, learning differences, sexual orientation)
  - Safe space messaging to students who aren't able to share with their families or peers
- What is the crucial message to communicate?
  - To students: provide a jump start/head start, fun, valuable use of time, able to connect with others, you will get ahead!
  - To students (may not know what they need): delivering message via former student (closer to age, easier to connect)
  - To students: tie message to specific post secondary plan (i.e. we know you want to go to X to study X this program is for you)
  - Biggest message: YOU'RE NOT DONE YET until every box is checked (put it on a billboard!)
- Support needed in marketing/communications?
  - Ask students: what do you wish you had between junior and senior year?
- Opportunities to collaborate and/or cross-promote summer programs?
  - Opportunity to collaborate with employers to structure a paid job/summer program (with fair wages)
  - WBL opportunities with MNPS employer engagement WT cross-over/support?

- MOBC collaborates with Power Youth learn from what they do, potentially create a college model (expand on what already exists)
- Ask students: what do you wish you had between junior year and senior year (crossover with WT 2 survey to FLEX/GRAD students?)

### Early indicators of melt

- Demographics
  - Historically marginalized individuals (race, ethnicity, disability status, etc)
  - Gender
  - Socioeconomic status
  - First or second generation students
- GPA/ACT if they find out they have to take remedial classes, they may not go
- Attendance

### Reasons for melt

- Academic fatigue
- Technical barriers
  - Paperwork not being processed or submitted (transcripts, FAFSA verification)
- No relationship with college rep
- Transportation or housing changed (or never existed)
- Not enough scholarship money
- Communications that go to students (and methods) differ widely
  - Too many emails and they don't know they have to read emails
- Not taking initiative/asking for help
- Growth mindset is not pushed until it's too late
- Senior year is a lot of change all at once and college planning starts too late/isn't individualized enough
- Parents and families not involved
- Lack of direction/career counseling
