III. Faculty Senate Chair's Report (J. D'Ambroise)

- Appointments to committees
 - 1. PRODiG: no self-nominations during open period
 - a) Fred Millan, Jasmine Mitchell, Deepa Jani (continuing) & Sylvie Kande (new) 1-year position
 - 2. CAP
 - a) Anissa Lynch appointed to fill vacancy
- Update about Presidential Committees: concerns about reducing redundancy
 - 1. Met with JoAnn Robinson
 - 2. Faculty Experience Committee seen as redundant with IT governance and Full-Time Faculty Task Force
 - 3. Student Experience Committee also may be redundant, but didn't have time to discuss
- Chair's statement: Money available from governor's office for new hires.
 Consultation with CAP and PBC. Faculty have some concerns about how consultation was conducted. Want faculty to be looped in to the process earlier when initiatives like this come from the state
 - 1. Jeffery Fischer-Smith: how do you want calls for proposals from outside funders shared? Or is this not pertinent
 - a) Jennie: depends on whether it has an impact on curriculum. Depends on the nature of the proposal
 - 2. Tim Sams: "in principle I don't have a problem with anything that you've outlined there"
 - 3. Mike Kavic: from the research ops side, we do want to publicize these opportunities to the campus

IV. President's Report (T. Sams)

- The funding from Hochul
 - 1. Some enrollment focused for student retention and support
 - 2. Some for new hires
 - Unclear if the funding is permanent, so not going to offer these jobs as TT
 - (1) Purpose is to diversify faculty
- Social justice center
 - 1. Building in woodlands
- Meeting with SGA leadership
 - 1. Food is imporved
 - 2. Concerns
 - a) Part support
 - b) Too many classes cancelled/moved remote
 - c) Desire more/better faculty support (advising)

V. Provost's Report (D. Quarless)

- OW model being rolled out
 - 1. Institutional effectiveness involved in this: James Cribbs
- Office of institutional advancement has new dir: Shanthi Konkoth
- Blended modality being phased out

VI. UUP Report (M. Livingston)

- Concern that admin is anti-work from home, telecommuting. Cancelling blended is part of that
 - 1. Telecommuting is one of the new contract priorities
- Contract negotiations going on

- Decision to drop the in class masking mandate the day before classes started was concerning. Responses are mixed from faculty survey about this
 - 1. Lorenz: can we see the data on the survey?
 - 2. Martha: yes

VII. Title IX Office Report (Stephanie laccarino)

- Proposed new regulations to change Title IX
- If a student comes to you, it's not your job to investigate the situation. Report it to the Title IX office: tix@oldwestbury.edu. 418-H campus center: 516-876-2740
 - 1. Sarah Smith: there is criticism of mandatory reporting and how it takes autonomy away from victim, but DOE requires it. It used to be that campuses could get creative about **who** is a mandatory reporter. Do the new guidelines force faculty to be mandatory reporters or is that campus/system-specific?
 - 2. Stephanie: that is in the federal law, not something in the proposed new regulations, the final rule could change. I have a feeling the status quo (about reporting obligations) will remain bc of the Cleary Act
