Help Secure Funding for a Permanent Wildlife Crossing on Chileno Valley Road

Right now, the Transportation Authority of Marin (TAM) is deciding how to spend Measure AA transportation funds. This only happens once every six years, and decisions will be finalized in early March.

We are asking TAM to fund a planning grant to design a permanent wildlife crossing under Chileno Valley Road—the step that will make construction possible later.

Your voice matters. **These 4 actions take 10 minutes and collectively create significant pressure on decision-makers.**

To the Editor,

I appreciated the Marin Voice column “Chileno Valley Road crossing is deadly for our newts” (Jan. 30). As the article explains, this road has become a dangerous barrier for wildlife trying to reach Laguna Lake.

Volunteers have spent years helping newts and frogs cross safely, but hand-carrying animals across a busy road is not a permanent solution. What’s needed is infrastructure that allows wildlife to cross safely on their own.

The Transportation Authority of Marin is currently deciding Measure AA funding priorities. This is a rare opportunity to support a planning grant for a permanent wildlife undercrossing that protects animals, improves safety, and reflects community environmental values.

I urge TAM to make this project a priority.

**ACTION 2: EMAIL TAM COMMISSIONERS**

TAM commissioners track public input and consider it when setting funding priorities. Messages from both Marin and non-Marin residents show broad public support.

Dear [Commissioner / TAM Board],

I'm writing to urge you to support funding for a planning grant for a permanent wildlife crossing on Chileno Valley Road.

Each year, thousands of animals are killed trying to cross this road to reach Laguna Lake. Volunteers have stepped in to help, but this is not a long-term or scalable solution.

Funding planning now allows wildlife crossing improvements to be included when the road is repaired, saving time and public money later. Measure AA was approved to maintain roads while also protecting environmental quality, and this project clearly does both.

Please support funding for the Chileno Valley wildlife crossing planning grant.
