



## San Ramon FC 2025 Financial Aid Guidelines

**Objective:** San Ramon FC (SRFC), provides interested and motivated youth the opportunity to play soccer at the level that fits their skill and ability. SRFC strives to keep soccer affordable, so all youth have an opportunity to participate. As such, the SRFC Financial Aid program is intended to provide opportunities for financially disadvantaged youth players to participate in SRFC programs.

**Privacy:** All Financial Aid applications and financial documentation information provided will be kept CONFIDENTIAL. For the privacy of our applicants, all documentation provided will be destroyed or returned (upon request) after the SRFC Financial Aid Committee approves or denies the request for financial aid.

### Guidelines

Application Submission Deadline for ALL levels of play: **July 31, 2025**  
*or until budgeted funds have been depleted (whichever comes first)*

- Financial need must be demonstrated for consideration. Economic hardship will be the only factor in awarding Financial Aid. No one will be disqualified from consideration because of sex, race, color, creed or religious beliefs.
- Financial Aid is awarded for our Competitive (including U8 Academy), Fall Recreational and Junior Academy Programs only.
- While we try to address as much of the need as possible, Financial Aid amounts will be based on the number of players demonstrating need, the extent of that need and the budget available for Financial Aid that year.
- Financial aid is considered for qualified recipients after a completed financial aid application has been received along with all supporting documents.
- The total amount of financial aid awarded will be decided by the financial aid budget for each division, the number of applicants and apparent needs.
- Financial aid awarded ***does not cover uniform costs or team fees for competitive level players.***
- 4 to 10 hours of volunteer work for the club is required for each child being awarded financial aid.
- San Ramon FC does not use financial aid as a recruiting tool.
- Families awarded financial aid will have the option of a payment plan for the balance of club & team fees due. Players that do not meet their financial obligations will be suspended from training and games until their account is made current.
- After completed application is received along with all required documentation, financial aid committee will review and notify families of a decision within 14 days

### Criteria and Eligibility

To be considered you must:

1. Complete and submit an application for Financial Aid in its entirety.
2. Supply a copy of your 2024 filed Federal Tax Returns. If you have not yet filed your 2024 return, supply a copy of your 2023 filed Federal Tax Returns and your 2024 1099 and/or W2's for all family members living in a household or financially responsible for the player.
3. Supply a copy of the last two pay stubs for each working parent (or proof of EDD or Disability).
4. Supply copies evidencing sources of income, including child and spousal support.
5. Include any additional documentation demonstrating financial need.

Applications received after the published deadline or are not filled out completely (e.g., unanswered questions, missing supporting documentation, etc.) will not be considered. Applications must be filled out by the adult requesting Financial Aid

and may not be filled out by coaches, team managers, children or friends. Any unpaid league fees from prior seasons will result in an applicant being ineligible for Financial Aid in the future.
