The article is written in English with proper and correct sentences and contains the background, rationale, and/or urgency of the research. References (relevant literature or research) must be included in this section, along with their relevance to the justification of the urgency of the research, the emergence of the research problem, alternative solutions, and the chosen solution. The citation of sources within the text must clearly indicate the author's name and the source citation, including the publication year and the page number where the text is located. For example: research findings indicate that over 70% of students are unable to identify authentic problems.... . The introduction is written in Times New Roman 12 font, with 1.15 line spacing. Each paragraph begins with a word indented approximately 1 cm from the left edge of each column.

The research problem, objectives, and significance are written narratively in paragraphs, without the need for specific subheadings. Similarly, operational definitions, if deemed necessary, are also written narratively. (Fuad Fachruddin, 2006)

References in this journal should be from the last 10 years at most and come from primary sources to strengthen the justification of originality or contribution of this research title. Before stating the research objectives, there must be a Gap Analysis or a clear and explicit statement of originality (originality statement) or a statement of novelty (novelty statement), or what distinguishes/makes this research unique compared to previous studies, as well as the importance of conducting this research. Only then should the research objectives be clearly and explicitly stated in this article.
